Annual Confidential Report for the Year 2019-20 (Case ID No. 1923)

Sir,

It is humbly submitted that Annual Confidential Remarks given by the District Judge were communicated to me vide letter no. 109(4)/MACT/Registrar on 25-01-2021. It is further submitted that with all due respect, I humbly represent against the following remarks given by the Learned District Judge made in---

- 1. Column No. 1(e) (iv) of the Annual Assessment regarding progress and disposal of execution cases was shown as:-
  - 1(e) (iv) Progress and Disposal of Execution Cases: NIL
- 2. Remark given by the District Judge made in Column No. 2 of the Annual Assessment regarding Overall Assessment of the merit of the Officer wherein I have been awarded "Good" entry by the respected District Judge

With regard to Point No. 1 relating to Execution, I humbly beg to bring in kind notice of the Hon'ble Court that during the year 2019-20 I remained posted as Civil Judge (S.D.), Mainpuri from 24-08-2019 to 31-03-2020 and the statement enclosed with my Self-Assessment clearly reveals that for the period 24-08-2019 to 31-03-2020, 77 regular executions were pending on 24-08-2019 in the court of Civil Judge (S.D.) Mainpuri out of which 34 execution applications were stayed, 04 execution applications were instituted during the period 24-08-2019 to 31-03-2020 and **04 execution applications were decided by me.** This fact has been also mentioned by me in Annual Self-Assessment, Form Part II in Point No. 2 i.e. Norms set and achieved in respect of disposal of cases that **04 execution applications were decided by me.** Thus it appears that an inadvertant factual mistake has been made by the learned District judge in recording the fact that I have not decided any execution application and perhaps due to this factual mistake the Learned District Judge recorded "Good" entry as my overall assessment.

It is pertinent to mention here that during the Assessment year 2019-20 my courts were also frequently changed. I presided over the Court of CJM, Deoria (01-04-2019 to 15-04-2019), ACJM-II, Mainpuri (18-04-2019 to 31-07-2019), ACJM-I/Principal Magistrate J.J. Board, Mainpuri (01-08-2019 to 23-08-2019), Civil Judge (S.D.), Mainpuri (24-08-2019 to 31-03-2020), where in addition I was also discharging functions of Secretary, DLSA, Mainpuri during the same period

and despite the above frequent change in Courts, I achieved 2624.69 Units (218.72 %) and disposed old cases as well as contested cases.

I also humbly beg to bring to kind notice of the Hon'ble Court that in his remarks the respected District Judge has nowhere mentioned anything adverse to my integrity, work or conduct. In fact, it has been recorded that I achieved 2624.69 Units against target Unit 1200 which is 218.72 % and much above than target Units. The details of old cases decided by me was also recorded by the District Judge.

Apart from it, I also contributed in administrative work which was entrusted to me. I was Officer in Charge, Copying Department, Mainpuri, Assistant Central Public Information Officer, Member of various Committees such as- Grievance Redressal Committee, Prevention of Sexual Harassment of Women at Workplace, Action Plan Committee, UP Civil Court Staff Centralized Recruitment 2018-19 Committee, Committee for Oath Commissioner, Promotion Committee, Committee for Survey Commissioner, Purchase Committee.

Therefore, I most humbly submit that remark recorded against Column No. "1 (e) (iv)" of the Annual Confidential Remarks that progress and disposal of execution cases was NIL is a factual mistake which has consequently degraded my overall assessment as "Good", which does not properly justify the efforts which I put in judicial and administrative work during the Assessment Year and the same needs to be reconsidered.

It is most humbly prayed to the Hon'ble Court that the above mentioned facts may kindly be considered and It may kindly be recorded that I have decided 4 execution applications and the "GOOD" entry in Column No. 2 regarding the overall assessment may kindly be upgraded to any other higher suitable entry which the Hon'ble Court deems fit.

Copy of the statement of institution, disposal and pendency is being enclosed as **Annexure-1** for kind perusal of the Hon'ble Court.

It is humbly requested that my submissions may kindly be placed before the Hon'ble Court for kind and sympathetic consideration.
