Subject- A humble representation against the impungned adverse remark awarded by the Hon'ble District Judge, Firozabad in self assessment for year 2020-2021.

Sir,

Most respectfully, I have the honour to submit my this humble representation against the annual remark awarded by the learned District Judge Firozabad, para wise submission out infra-

The learned District Judge in Para 01(a) has mentioned the integrity of the applicant doubtful stating that several complaint from Bar regarding corruption have been received and numerous transfer applications were moved against the applicant alleging extraneous consideration.

To this end, I have to submit that the learned District Judge has not sent me any complaint application submitted to him by Bar to submit explanation from my end. No member of Bar has even made any complaint against me alleging corruption and the learned District Judge never called any explanation forwarding corruption charge complaint made by the member of Bar. No transfer application too, has been made against me by any member of Bar alleging extraneous consideration. The word extraneous means irrelevant, that is I never made any irrelevant consideration in any case. If any transfer application was moved, it was not at all based on corruption basis nor an irrelevant consideration. Often transfer applications are moved in the court of District Judge relating to different courts on some other reasons and the cases are transferred it does not affect the integrity of the Presiding officers. It is also submitted with respect that no complaint with regard to corruption has been moved against the applicant on any footage. No Demi Official letter has been issued to me by the learned District Judge stating corruption charge.

On the basis of above facts, supra, I most humbly request that my integrity can not be doubtful. It is also to submit to the Hon'ble court that since



2015-2016 to 2019-2020 my integrity was also always certified and mentioned beyond doubt by the District Judge under whom kind subordination I had worked.

In para 01(b) the learned District Judge has stated that the officer is not fair in dealing with the public and Bar.

To this end, I most humbly submit that I always worked under the guidelines issued by the Hon'ble Court with regard to Covid-19 pandemic and work fairly in the court. No person of public not any member of Bar raised any voice against me making any complaint. The learned District Judge has himself mentioned in para 01(c) that the officer is cool minded and not loose temper in the court which shows that my conduct always remained fair. Which resulted cordial relations with all. With regard to my conduct and behaviour, no complaint was moved in any way on any platform.

In para 01(d) the learned District Judge appreciated my private character and estimated that it never adversely affected the discharge of official duty. He was also stated in para 01(e) (i) (b) that I always kept myself engaged in court work during full court hours. It also shows that I always concentrated myself towards my official duty and court work in accordance with the guidelines of Hon'ble court.

In para 01(f) the learned District Judge has stated that 'Average 'there is large scope of improvement in Judgment writing.

To this end, I have to submit most respectfully that my orders were never revised in any revision or appeal commenting on Judgment writing nor in any monthly meeting I was advised on this point. I passed all the orders purusing full case file, marshaling the facts and appreciating the evidence. I passed the order with proper application of mind. Resultantly, I received no order in judicial side on the point of evidence and law.

In para 01(l ) the learned District Judge has stated that the officer is not punctual and irregular in sitting on dias.

To this end, I most humbly submit that I used to sit on dias under the guidelines of Hon'ble Court issued with regard to Covid-19 pandemic. The daily sitting register was always sent to learned District Judge in time and I was never found absent on the time daily sitting register sent.

In para (4) The learned District Judge stated that the officer lacks administrative quality and advised to change her irresponsible behaviour towards her work.

To this end ,I have to submit that Hon'ble court that in para 01 (k) the officer has made regular inspection of the court and those are full and effective. It shows that I had full control on my office and officials. No official made any



complaint with me with regarded to my behaviour nor made any complaint to Learned District Judge with regard to my behaviour and conduct even class IV staff has no complaint with me.

Lasting I submit to the Hon'ble court that my overall assessment is made as 'Average' by the learned district judge so I submit that I always devoted myself towards my duties and work. My work done was also upto the mark. I have been serving subordinate judiciary since 2015-16 and work was always appreciated by the District Judges under whom kind subordination I have served.

On the basis of the above, I most humbly request that Hon'ble court may graciously be pleased to consider my this representation in favor and further, may graciously be pleased to expunge the remark given by the learned District Judge Firozabad with regard to the integrity and to upgrade the overall assessment of the applicant.

I shall ever be grateful to the Hon'ble Court.
