## <u>Representation against remarks by District Judge Etah in Annual Confidential</u> <u>remark Year 2020-21</u>

Respected Sir,

I am submitting my representation against remarks given by District Judge, Etah in Annual Confidential remark 2020-21.

## Remark of column 01(g)(i)- Number of cases decided after actual full contest;

It is humbly submitted that, in this Column The District Judge has shown that the Cases decided after full contest by the Officer is **Nil** (As per the statement submitted by the concerned officer), but during the period Year 2020-21, I have decided **30 Cases** after full contest, the fact which might have been missed by The District Judge. It is also shown in the Year-wise Statements of Judicial Magistrate, Etah and I have also submitted **Highlighted Statement** with this representation in which it is shown that **30 Cases** have been decided by me after full contest. it may be confirmed in my units statement as well **(also Attached with this representation, cases highlighted)**. It is humbly requested to kindly consider my representation and consider 30 cases instead of Nil.

## Remark of column 01 (e)(iv)-Progress and disposal of execution cases:

In this remark, the District Judge has remarked that No Execution case is disposed in the assessment year (5 Regular Execution were pending) (As per the statements given by the concerned officer).

It is humbly submitted that I was posted as Additional Civil Judge(Jr. Div), Court no. 25, Etah from 01.04.2021 to 30.07.2021 during the Assessment period of 2020-21, in that Court, 05 Regular Execution cases were pending. Due to Covid-19 Pandemic, the court were closed from 01.04.2020 to 07.06.2020, and from 08.06.2020 to 30.07.2020 the court were functioning to the extent of urgent work. even after putting my best possible effort, No execution case could be decided as very few litigants were attending the court.

On 30.07.2020, I got transferred to the Court of Judicial Magistrate(Criminal Work Only) by Order of Hon'ble High Court. From 30.07.2020 till 31.03.2021, I was posted as Judicial Magistrate. In the Court of Judicial Magistrate Court, No Execution Case was pending, that is why no execution case could have been decided. In view of the above, It is humbly requested to Expunge the entry in column of Execution Case and not to consider adverse against me.

It is, further, humbly submitted that during that assessment period, even most part of the period, the Court was Closed or the functioning of Court was limited to Urgent work due to Covid-19 pandemic, I have given **1714.44 Units** work done . Although, the Standard Unit of work is **1200**. I have disposed **30** Cases **Contested, 29 cases** 5-year Old and **25 cases** 10-year Old were disposed. In column 01 (g) of annual confidential remark, the respected district judge considered that the Work done by the Officer is "**Adequate**" and the work done by me is more than standard units. In view of the above, the overall assessment of me may be Upgraded.

Therefore, I humbly request to Hon'ble Court to expunge the remarks made by Respected District Judge in Annual Confidential Report 2020-21 and upgrade the Overall Assessment of the Officer. I shall be highly Obliged.

I request respected sir to place my Representation before the Hon'ble Court for kind consideration.
