Subject- Representation against annual confidential remark given by the Hon'ble Mrs. Justice Sadhna Rani (Thakur), the then District Judge, Ramabai Nagar (Kanpur Dehat) .

Respected Sir,

Most humbly I submit on the subject mentioned above as follows:-

1- Hon'ble Mrs. Justice Sadhna Rani (Thakur), the then District Judge, Ramabai Nagar (Kanpur Dehat), in her annual confidential remark rated me as "an average officer" and rated my over all assessment as "Good" and Integrity was "Certified". In this regard I have to submit that during the assessment period from 01-04-2020 to 31-03-2021, due to Covid-19 Pandemic, the normal functioning of the court/ judicial work started from 02-01-2021. Despite this, I have achieved total 1054.15 units for the whole assessment year and a total of 348.5 units were achieved in three months during the period 02-01-2021 to 31-03-2021 (total 60 actual working days). When the judicial work started from 02-01-2021, then for almost a month litigants and counsels hesitated to appear in the court due to fear of Covid-19. Despite this, I have done my all efforts for presence of witnesses and decided the criminal cases despite dismal performance of the police machinery regarding securing the attendance of witnesses in the court and I decided 09 Criminal Appeals, 04 Special Sessions Trials U/S 376 IPC and Pocs0 Act, 04 Sessions Trials u/s 376 IPC, (in which 04 cases were more than 5 years old and 01 case was more than 10 years old), 01 application u/s 156(3) Cr.P.C., 06 Final reports, 05 applications u/s 311 Cr.P.C., 01 complaint case u/s 203 Cr.P.C.. During the aforesaid period charges were framed in 47 cases, 567 pages of evidence was recored, 09 statements u/s 313 Cr.P.C were recorded, 01 statement u/s 200 Cr.P.C. and 01 statement u/s 202 Cr.P.C. were recorded during the assessment period. The Special Sessions Trial and Sessions Trial cases disposed by me during that period range from year 2009 to 2017. All these Special Sessions Trial cases and Sessions Trial cases, decided by me,

were in the category old and very old cases. My disposal during that period reflects my sincerity and the efforts made in the disposal of old cases. In addition to above it is also submitted that I am officer in charge of Civil Copying department and I have devoted time to perform my duty as officer incharge also. I have achieved total of 1054.15 units during the assessment year. The shortfall in achieving standard target units has been exempted/relaxed by Hon'ble High Court vide it's Letter no.671/CF(B)/2021:Allahabad:July 17, 2021. Therefore, the remark that **“He is an average officer”** is not sustainable as is evident from the record furnished in the self assessment for the period 01-04-2020 to 31-03-2021.

2- The Hon'ble Mrs. Justice Sadhna Rani (Thakur), the then District Judge, Ramabai Nagar (Kanpur Dehat) overall assessed me as a **“Good”** and had **“Certified”** my integrity but at the very same time, without assiging any reason, I was rated as “an average officer”, which is **self contradictory, baseless and is liable to be expunged**. During the assessment year 2020-2021, adverse conditions due to Pandemic Covid-19, the quantum of my disposal as well as my endeavour to dispose off Sessions trial cases and other disposal were not looked into while rating me as an average officer. Keeping in view the facts narrated in this representation about the my rating as “an average officer” be kindly reconsidered and expunged.

#### **PRAYER**

It is therefore most humbly prayed that this representation may kindly be placed before Hon'ble High Court to remove/expunge the following remarks recorded by the Hon'ble Mrs. Justice Sadhna Rani (Thakur), the then District Judge, Ramabai Nagar (Kanpur Dehat) from my annual confidential remarks for the period 2020-2021:-

**“ He is rated as an average officer”.**
