Sir,


It is humbly submitted that the remarks given by the District Judge in Annual Self Assesment for the year 2020-2021, were communicated to me through online portal on 16-08-2021.

Wherein the Remarks given by the District Judge made in column number 2 of the annual assement regarding Over all assessment of the merit of the Officer "**Good**" entry has been awarded by the respected District Judge. In this regard it is submitted.

1- That I humbly beg to bring to kind notice of the Hon'ble Court that in his remarks the respected District Judge has nowhere mentioned anything adverse to my integrity, work or conduct. In fact it has been recorded that I achieved 1952.94 units against required units 1200 which is much above than target units. The details of old cases decided by me was also recorded by the District Judge. Apart from it, 928 Petty Offence Cases, 873 Bail Applications, 201 Cases Committed to Sessions Court, 298 Applications under Section 156 (3) Cr.P.C., 63 Applications under Section 155 Cr.P.C, 45 Final Reports, **02 Preliminary Inquiry**, etc. were decided.I have disposed 131 cases in Lok Adalat.

2- That apart from it, I also contributed in administrative work which was entrusted to me. I was Officer In Charge, Copying Department, Mainpuri,Assistant Central Public Information Officer, Member, Grievance Redressal Committee, Member, Prevention of Sexual Harassment of Women at Workplace, Member, Action Plan Committee, Chairperson,Sexual Harassment of women at work place complaint Committee, Officer-in-Charge (Protocol), Officer-in-Charge (Security), Officer-in-Charge Criminal Copying, Member,Committee constituted for compliance of PIL No.15895/2015 dated 24.03.2015 , Member, Malkhana Committee at different point of times.

3- That it is pertinent to mention here that during the assesment year 2020-21 despite limited functionality of courts during Covid-19 and excess of administrative work and at the same time discharging functions of Secretary, DLSA in addition to C.J. (S.D.) Mainpuri, organizing legal aid camps, imparting


training to PLVs, etc. I achieved 1952.94 units and disposed old cases as well as contested cases.

Therefore I most humbly submit that "Good" entry does not properly justify the efforts which I put in judicial and administrative work during the assesment year and hence, it is most humbly prayed to the Hon'ble Court that the above mentioned facts may kindly be considered and the "GOOD" entry in column number 2 regarding the overall assesment may kindly be upgraded to any other higher suitable entry which the Hon'ble Court deems fit.
