Subject:- Request for expunging certain critical remarks recorded by Respected Mr. Sanjay Shankar Pandey, District and Sessions Judge in my self-assessment column number 01(k) and other remarks in column number 4.

Respected Sir,

The applicant most humbly begs to submit her representation on the above subject matter as under:

1. That the applicant, is a newly inducted judicial officer and has joined judicial services on 16.12.2019.
2. That the applicant was undergoing Dias/Field Training organized by I.J.T.R. in Gonda from
 - 17.12.2019 to 21.03.2020,
 - 01.06.2020 to 12.06.2020,
 - 06.08.2020 to 25.09.2020,
 - 13.10.2020 to 14.10.2020.
3. That the applicant was undergoing Online Training Programme (phase I & II) organized by I.J.T.R. from:
 - 22.06.2020 to 05.08.2020

- 07.12.2020 to 30.01.2021
4. That the Civil court at Gonda remained closed due to Covid-19 Lockdown from 01.04.2020- 31.05.2020.
 5. That the applicant tested Corona positive on 25.09.2020 and under quarantine leave from 25.09.2020-12.10.2020.
 6. That the applicant presided over court from 15.10.2020 as civil judge junior division FTC II . And then by the order of *Hon'ble* court transferred in court of civil judge junior division FTC new on 11.11.2020.
 7. During the period of assessment year 2020-2021 Learned District Judge, Gonda, While recording my annual confidential remark observed as:- overall assessment of the merit report of the officer is **GOOD**.
 8. That against point no. 01(k) of my A.C.R. which states, “Whether the officer has made regular inspections of his court and offices in his charge and whether such were full and effective?”, the learned District Judge has observed that **“The officer has made quarterly inspections regularly, court and office in his charge but the inspection is not effective.”** And In column no 4 ***“though overall officer has good administrative capability but he never comes forward to share their responsibility. Officer has not used his ability to supervise in his own office in accordance with rule and circular letter of Hon'ble Court. There are chances of improvement in his administrative capacity”***
 9. That the applicant due to Training and Covid-19 Lockdown could not inspect her Court for first three quarters. However, the Court was inspected for the fourth quarter i.e. 01.01.2021-31.03.2021 on 31.03.2021. But inspection note could not be submitted before the then respected District & Sessions Judge due to his transfer . The inspection note was submitted on 19.08.2021 before present Respected District & Sessions Judge and no remark has been made by the present Respected District & Sessions Judge Shri Mayank Kumar Jain on the inspection note .And No other office in charge

was given to the applicant. Thus The Then Respected District and Sessions Judge Shri Sanjay Shanker Pandey never perused my inspection note .Hence the entry made by the Respected District and Sessions Judge Shri Sanjay Shanker Pandey in column no (1) (k) and (4) may kindly be expunged.

10. That the applicant has made all possible efforts for proper functioning and working of court even during the covid-19 period.
11. That the applicant never received any direction either orally or in writing by the Respected District and Sessions Judge Shri Sanjay Shanker Pandey during the above assessment period about the administrative capacity in the court and office. Besides, in Column No. (1) (h) the Respected District and Sessions Judge Shri Sanjay Shanker Pandey has observed that “***control over the office and administrative capacity and tact is proper and effective***”. Hence the entry made by the Respected District and Sessions Judge Shri Sanjay Shanker Pandey in column no (1) (k) and (4) may kindly be expunged.
12. That the applicant never received any direction either orally or in writing about sharing of any type of responsibility.
13. That the applicant never received any direction from the then Respected District and Sessions Judge about work efficiency, inspection of office/ court or about the rules, regulations and circular letters of Hon’ble court. During his tenure the applicant has never received any DO letter or any other direction about non-compliance of such rules, regulations and circular letters of Hon’ble court.
14. That the applicant has done her work with full potential and conscientious and has always made keen interest to the best capability for the proper functioning and running of court according to the rules and regulations/ circular letter of Hon’ble court in the pandemic period. And disposed 11 civil cases and 180 other criminal misc.cases and achieved 233.53 unit against 167.66 unit actual working days(67)during the assessment year target.

15. That the applicant hence forth will always make efforts and is intently determined to improve her administrative work to her full capabilities.
16. It is, therefore, most humbly prayed that your good self may kindly place this representation of the applicant before the Hon'ble court for considering my representation sympathetically and keeping in view that the applicant is a new entrant in the judicial service and has received foundation training at gonda .The Hon'ble court may be pleased to expunge adverse remark made by the then respected district & sessions judge Gonda recorded by him in the point no. 01(k) and column no. 4 of my A.C.R. .The applicant shall ever be grateful for the kindness of Hon'ble court .
