With all due humbleness and regard, the undersigned wants to say that I am newly entrant in Judicial service. I had to submit my representation against remark passed by Hon'ble District Judge Jalaun at Orai for the assessment year 2020-21 within 1 month from the date of uploading of ACR. But I deeply regret that due to my lack of knowledge, i could not submit my representation within time. I most humbly request to grant me condonation of delay and accept the submission of my representation. Submission of my representation against remark passed by Hon'ble District Judge Jalaun at Orai for the assessment year 2020-21 in columns 01(f)(i) and 2 is as follows,

- 1. I joined as Judicial Magistrate Orai from 20.11.2019 to 30.11.2020 and thereafter took charge as Civil Judge (J.D.) Orai from 30.11.2020 (afternoon) to 31.03.2021.
- During the entire period of assessment year 2020-2021 i.e. from 01.04.2020 to 31.03.2021, I
  had undergone Dias Training till 06.11.2020 and held the dias on 07.11.2020. Afterwards i
  had also undergone Online Induction Training Programme (Phase-II Institutional Training)
  for Newly Appointed Civil judges(J.D.) from 07.12.2020 to 30.01.2021.
- 3. Hence my actual period of working was between 07.11.2020 to 06.12.2020 and from 31.01.2021 to 31.03.2021.

- 4. From March 2020 to 15.06.2020, Court remained completely close due to Covid-19 pandemic. Afterwards till December 2020, work was done in restricted environment due to Covid-19 guidelines.
- 5. After the Judicial work was resumed according to the directions of Hon'ble High Court, I was undergoing online induction training till 30.01.2021.
- 6. During that short period when i held the dias, I had given 242.06% disposal/out-turn. I decided 3 cases after full contest. I also decided 3 cases on the basis of compromise. I disposed of 7 cases from old category, in which the oldest was of the year 1992.
- 7. I also held the charge of- Chief Judicial Magistrate, Addl. Civil Judge (J.D.) Orai, Civil Judge (J.D.)/FTC (Crime against Women), Civil Judge (J.D.)/FTC 14th Finance Commission, Spl J.M.-I, Spl. J.M-II.
- 8. During the assessment period, I was also member of:- Infrastructrue Sub-Committee, Member of Purchase Committee, Member of Grievance Redressal Committee, Member of Internal Complaints Committee-Sexual Harassment at Workplace.
- 9. Hon'ble District Judge remarked positively on:-Column 01(a) that, "integrity of the officer is beyond doubt", Column 01(b) that, "officer is fair and impartial in dealing with the public and the Bar members",

Column 01(f) that "judgments provided by the officer are in good language and satisfactory",

Column 01(f)(ii) that, "properly appreciated the evidence",

Column 01(f)(iii) that, "supporting and appropriate laws has been properly appled",

Column 01(h) that, "she has proper and effective control over office"

- 10. In columns 01(f)(i), Hon'ble District Judge remarked that officer required improvement and in column **02**, the overall assessment of the merit of the officer is remarked as <u>Good</u>. Though the remark passed, is suggestive, still it may be taken as adverse in nature.
- 11. I have always been committed to my work. I have always tried and still constantly striving to improve my Judicial as well as administrative side. I further undertake to improve my work continuously.
- 12. If the above mentioned remarks will be taken as adverse in nature then it will definitely hamper my morale and shake my composure & confidence.
- 13. I sincerely and humbly pray to Hon'ble Court to look into the matter mercifully and expunge the remark in Column 01(f)(i) and upgrade the overall assessment under Column 02, so that I can continue my work with high morale and uplifted confidence.

I humbly request the Hon'ble Sir to put up my representation before Hon'ble Court for consideration.
