Order

In compliance of direction issued by the Hon'ble High Court vide letter no. Camp-Memo /SLSA-15/2020(PS/Sharan) Dated March 27, 2020, regarding Resolution of the High Powered Committee constituted in the light of the directives of Hon'ble Supreme Court in Suo Moto Writ Petition No. 01/2020 IN RE : CONTAGION OF COVID-19 IN PRISONS, the undertrial prisoners facing criminal cases in which maximum sentence is 07 years old presently confined in jails has to be released on interim bail for 08 weeks on furnishing personal bonds with the undertaking written on the personal bond itself that he/she shall surrender before the court after expiry of the interim bail period along with other conditions may be imposed by the Court if it thinks fit, considering the circumstances of the case.

Hence it is directed that the Officres will visit the District Jail as per schedule mentioned below.
