| Rakesh Srivastava(HON'BLE JUDGE) | Perused the representation and assessment made by the District Judge carefully. The District Judge has assessed the performance of the officer as pōor. A careful perusal of the record shows that there is no material pointing out anything against the integrity of the officer. Reference to the case of Sanjay Agrahari is of no use as the said case was decided on 14.5.2019. In the said year the integrity was certified by the Court. Nothing seems to have been done by the Court on the complaint made against the officer in the above case. No other material has been pointed out or referred regarding the integrity of the officer. The comments made by the District Judge are not borne out from the record. No complaint has been made by any member of the Bar regarding the integrity of the officer. For Corona period certain guidelines were issued by the Court to be observed by the officers of the district judiciary. Taking over all circumstances into consideration, I am of the view that the representation deserves to be allowed. Adverse remarks made by the District Judge are expunged.
