The Hon'ble High Court vide it's Circular Letter No. 06/2023/Cf. (C) Allahabad: 04.03.2023 has desired the submission of Annual Remarks about the work and conduct of the Judicial Officers for the year 2022-2023 (01.04.2022 to 31.03.2023) of Kanpur Nagar Judgeship in requisite proforma through e-Services Module.

All the Judicial Officers are hereby directed to submit one copy of their Self Assessment Form (Part-I & Part-II), duly filled up with all particulars, latest by 10.04.2023 in Administrative Office. The Judicial Officers shall certify that they have personally checked and verified their Self Assessment Form alongwith the statements. Soft copy of the Self Assessment Form shall be uploaded on e-Services Module by 30.04.2023.

If any officer has presided over more than one Court during the assessment year whether at the present place of posting or other station, the year wise breakup of all the cases of different Courts, should be annexed with Self Assessment Form.

In the light of directions given in the Hon'ble Court's Circular Letter No. 60/81 Dated 19.09.1981, Additional District & Sessions Judges shall submit at least one copy of contested judgment delivered by them during the assessment year, of Session Trial, one of Conviction and one of Acquittal on merit, one of Civil Appeal, one of Criminal Appeal, one of Civil Revision & one of Criminal Revision.

In the light of directions given in the Hon'ble Court's General Letter No. 1/IV-h-14/90 Dated 08.11.1990, Judicial Officers of Civil Judge (Senior Division) cadre and Civil Judge (Junior Division) cadre shall specifically mentioned whether the stenographer was provided to them or not, during the assessment year. Magistrates/Civil Judge (Jr. Div.)/(Sr. Div.) will also give their 3 best Judgments.

Statement of disposal of all types of old cases both contested and non contested mentioning the Case Number and Year shall also be furnished.

All the Additional District & Sessions Judges to submit the list of total number of cases remanded by them, details thereof along-with copy of judgments or order and mentioning the grounds on which the cases were remanded.

All the officers of Civil Judge (Senior Division) cadre and Civil Judge (Junior Division) cadre are required to submit statement regarding interim/injunction orders granted, refused or retained for sufficient reason.

All the Magisterial Courts shall furnish a separate statement containing pending enquiry regarding custodial death, number of enquiries completed and assigning valid reason for not completion of those enquiries.

Progress and disposal of execution cases showing the opening balance as on 01.04.2022 and pendency as on 31.03.2023 & also the number of cases disposed off during the assessment year (Dismissed in default/stuck off in part/full satisfaction), shall also be furnished.

Statement of cases decided at the end of assessment year (i.e. 31.03.2023) showing:-

- Number of cases decided after actual full contest.
- Number of cases decided wherein all witnesses of fact turned hostile and the case ended in acquittal.
- III) Number of civil cases decided on compromise/alternate dispute resolution/section 89 C.P.C. shown separately.

The unit system for assessment of work of Judicial Officers should be followed as refereed by the Hon'ble Court's G.L. No. 11/IV-h-14/2019 Dated: March 05, 2019, G.L. No. 06/IV-h-14/2021 Dated: April 06, 2021, G.L. No. 08/IV-h-14/2022 Dated: May 18, 2022 and G.L. No. 11/IV-h-14/2022 Dated: August 18, 2022.
