**Subject- Representation regarding Annual Confidential

Hardoi for the year 2022-2023.**

Respected Sir,

With reference to the above, it is most humbly submitted that point wise representation against Annual Confidential Remarks recorded by Respected District Judge, Hardoi are as follows.

Coloumn 01 (g). Whether disposal of work is adequate. (Give percentage and reasons for short disposal, if any)

Remarks by District Judge

Yes.

Total disposal of work is 1434.35 units. Thus, I found it adequate. The Officer has decided only 10 cases after actual full contest. The officer is advised to decide adequate contested case in future.

Representation

During the period of assessment I have worked as Civil Judge (Junior Division), Basti and Civil Judge (Junior Division) West, Hardoi. During this period I have been assigned with civil work only. Along with Original suits and Civil suits there has been filing of large number of miscellaneous cases as well as interim applications. Ad-interim applications/miscellaneous applications/ succession applications were also to be disposed by me on priority basis. I have disposed 10 cases on actual full trial. **I have disposed all the targeted cases under Action Plan 2022-2023.** In addition to above, I have disposed total 372 civil cases (including miscellaneous cases). These 372 cases also includes 30 oldest Original suits and 10 oldest Execution cases identified under Action Plan 2022-2023. Among above disposals **1 case was more than 52 years old, 7 cases were more than 42 years old, 12 cases were more than 22 years old, 152 cases were more than 10 years old and 282 cases were more than 5 years old.** In Lok Adalat I have disposed 54 civil cases including Succession

cases. I have also disposed 08 cases on compromise. I have achieved 1434.35 units which is 263.62%. In the compliance of General letter no. 11/IV-h-14/22 dated 18.08.2022, I have achieved 279.50 units which is 138.09% without Stenographer through out the whole assessment year.

The advised/comment in the column 01 (g). by the Respected District Judge may be treated adverse and consequently it may cause irreparable loss to my career as Judicial Officer.

Prayer:- The words "The officer is advised to decide adequate contested cases in future." may kindly be expunged keeping in the view overall work/disposals without stenographer even in the instituting/parent court.
