Respected Sir,

I most respectfully beg to submit my representation as under:

- 1. During the Assessment Year 2022-23, I was posted as Judicial Magistrate in Court No. 27, Barabanki till 04.07.2023 and thereafter, from 05.07.2023 onwards, I have been discharging judicial functions as Civil Judge (Junior Division), Outlying Court at Haidergarh, Court No. 24, Barabanki till date.
- 2. This representation only pertains to the observations in column 1(e)(iii) and 1(g) that the Presiding Officer has not achieved the target of Action Plan in the Court of Judicial Magistrate, Court No. 27, Barabanki.
- 3. In this context, it is most humbly submitted that as Judicial Magistrate in Court No. 27, Barabanki, the applicant had identified 35 cases towards Action Plan Year 2022-2023, in respectful compliance of the Hon'ble High Court's directions in this regard.
- 4. Thereafter, during the period between the commencement of the Action Plan (01.04.2023) till the date of leaving charge of the Court upon transfer to Outlying Court at Haidergarh (04.07.2023), I had disposed the following four cases out of the identified 35 cases.

It is respectfully stated that I had submitted the aforesaid data online on the e-Services Portal under the then active module of "Action Plan for Judicial Officers of the Uttar Pradesh 2022-23 (Information pertaining to stage at commencement of Action Plan)". A copy of the said information as sent to Hon'ble Court as above, is enclosed with this representation for kind consideration. Thus, during 01.04.2023 to 04.07.2023, I had disposed 4 cases under Action Plan.

It is also respectfully submitted that apart from the aforesaid, during the period 01.04.2022 to 04.07.2022, as Judicial Magistrate, I had also disposed of certain cases which had been pending for ten years or more, and cases which had been pending for five years or more, the details of which are mentioned in the Annexures V and VI which I had submitted with the original Self Assessment for Assessment Year 2022-23 (the same are enclosed with this representation as well).
- 6. It is thus most humbly requested that in light of the aforesaid information, the Action Plan disposal, with respect to my tenure as Judicial Magistrate, Court No. 27, be not considered as "Nil" but as per the information furnished above. It is respectfully submitted that Respected District Judge has very kindly remarked that Action Plan target has been achieved for my tenure in my Court presently held, i.e. Court of Civil Judge (Junior Division), Outlying Court at Haidergarh, Court No. 24.
- 7. I would also most humbly request the Hon'ble Court to kindly treat any omission or error on my part in providing data towards Self Assessment as inadvertent and unintentional. I most humbly pray that my request be treated with kindness and generosity.

It is thus most respectfully submitted that this representation be kindly placed before the Hon'ble Administrative Judge so as to enable his kind consideration of my representation together with the Self Assessment remarks for Assessment year 2022-23.
