Perused the remarks given by the District Judge, Etah.

The Officer, namely, Shri Vipin Kumar-III remained posted as Special Judge (Exclusive Court, P.O.C.S.O. Act)/Additional Sessions Judge Etah w.e.f. 01.04.2022 to 31.03.2023. The Officer has also remained posted as 1. Under Trial Review Committee, 2. Audit Compliance (Inspection and Recovery) Committee and 3. Munsi Advocate's Clerk Registration and Renewal Committee. Total units achieved by him in the assessment year in question were 2276.41 against targeted 1200 units. The Officer has disposed of 53 cases pertaining to five years old category. He is also stated to be fair and impartial in dealing with public and Members of Bar, cool minded and no incident has been reported to me with regard to loosing his temper in court. His relation with the Officers and Members of Bar were cordial and judgement passed by him also appears to be sound on facts and law and have been expressed in good language. He also appears to be punctual and regular in siting on dais in court and no complaint has been made to me about his work, conduct and integrity. He is also amenable to the advice of the District

Keeping in view the representation of the Officer, it is observed that the Officer appears to have disposed of sufficient number of old cases and his out turn of work is adequate.

His overall Assessment as assessed by the District Judge is 'Good', however, no reason has been given for assessment of the Officer as only 'Good' while similarly situated officers have been assessed by the District Judge as 'Very Good'.

Thus, keeping in view the performance of the Officer in the year under reporting, his overall assessment of merit is assessed as 'Very Good'.
