I have the honour to submit that on 29-05-2024 Annual confidential remark recorded by the Ld. District judge, Sambhal for the year 2023-2024, was communicated to me. The Ld. District judge, Sambhal in column No 01 (j) of A.C.R, with regard to behaviour in relation to sister/brother Officers (mention incidents, if any) has recorded the following remark.

"In general his behaviour is cordial except in case of C.J.M Smt. Archana singh, who has alleged interference in her court by written complaint".

At the outset, it is worthy to note that Ld. District Judge while recording the remark in column No, 01(n) regarding behavior towards women has recorded my behaviour with women is respectful and sensitive The Ld. District Judge after evaluating my work, behaviour, administrative control and legal approach has made my over all assessment as 'OutStanding.'

It is submitted that remark recorded in column No.1 (j) is not in consonance with the remark recorded in column No. 01(n) .The basis

of remark recorded in column No. 1 (j) on the basis of one complaint of C.J.M Smt. Archana Singh unfortunately and interestingly the nature of complaint was never communicated to me, as I am knowing this for the first time by way of a remark in A.C.R for the year 2023-2024.

It is not possible on my part to reply the complaint since contents of the same are yet to be known. Any displeasure by a single officer of the judgeship, (which is still not been shown or communicated) can not be the ground of assessment, since one officer dose not create a class in himself/herself. Ld. Disttict Judge, Sambhal has recorded in column No. 1(n) my behaviour with wommen respectful and sensitive, hence remark recorded in columnn No.01 (j) with regard to C.J.M Smt. Archana Singh is on conjecture , and also not in consonacne with the rest of remarks recorded in the A.C.R., Hence it is quite clear that above remark has been recorded inadvertently and liable to be expunged.

Your goodself is requested to place my representation befor the Hon'ble Court for kind consideration to expunge the remark recorded by the District Judge, Sambhal in column No.1(j) in my A.C.R for the year 2023-2024.
