It is most humbly submitted before your honour that this is my representation against the remark given by respected District Judge as below.

With respect to above remark I have to submit that-  
About remark in column no 3 in which respected District Judge observed me about my health "not too good, She moves on leave frequently on medical ground" in this regard I have to state that respected District Judge in his remark not specify about my any disease. In this reference I have to submit that I am not suffering from any permanent disease. In this assessment year, on investigation of the complaint of stomach ache, it was found that there was several stone in my gall bladder. Due to the above, I got severe infection ( Pancreatitis and chronic cholecystitis) and finally I had to get admitted to King George Medical University, Lucknow and had to undergo surgery. I took as much leave as was advised by the doctor from time to time. And as per the doctor's advice, I joined duty after I became

healthy and fitness certificate was presented before the District Judge. For this purpose I have to gone medical leave with permission of respected District Judge. He never asked to me about my health and he does not write any ground about his remark. It feels that remark given to me about my health, is without considering human perspective. I had never took leave on false ground. During my posting in Lakhimpur kheri ( 2 Years Period), I never go to any Earned Leave or child care leave. I also attach all of medical certificate about my health problems and fitness with this letter.

About the remark in column no-2, I have humbly submitted that I have always been a hardworking and dedicated officer. In spite of illness my dedication towards my work can be assessed by the percentage of work done by me. My actual target units for year 2023-2024 is 1200 units and achieved unit is 2493.98 units Which is much greater than target. I have always endeavored to reduce the pendency of cases which are more than 10 years old (36 cases) and 5 year old (41 cases). In spite of my medical leave I disposed action plan case- 8 civil appeal disposed form the target of 8 cases, 11 Criminal appeal disposed out of target of 8 cases and 5 Arbitration cases disposed out of target of 6 cases, 17 Case /Session Trial disposed of the target of 20 cases. In spite of this I also decided 109 actual full contested cases, 193 cases decided in Lok Adalat.

The respected District Judge stated I am the officer with integrity and is regular and punctual in sitting on dias. In Annual Confidential Remark- 2022-2023 my overall assessment was "very Good" granted by same District Judge. I have achieved more than required quantum of work over all as well as from final disposal but still my over all assessment is "Good."

On the basis of above mention facts I most humbly pray as Hon'ble court to consider my submission and expunge the remark given by respected District Judge as state of health "Not too good. She moves on leave frequently on medical ground in column No.-3 respectively in the Annual Confidential Remark and also to upgrade my overall assessment in column no 2 of the Annual Confidential Remark for the year 2023-2024. I will be highly obliged.
