Subject: Submission of representation against the Annual entry recorded by Shri Lallu Singh, the then District Judge, Jalaun at Orai for the Assessment Year 2023-24 communicated through e-services portal for judicial officers on 05/05/2024.

Respected sir,

I most respectfully beg to submit my representation with the utmost hardship on the subject noted above as under:

1. That during the Assessment Year 2023-24, I was posted as Addl. Civil Judge (S.D), Court No-1, Agra from 1-04-2023 to 28-04-2023, Civil Judge (S.D/F.T.C) Jalaun at Orai from 29-04-2023 to 21-11-2023 and Addl. Civil Judge (S.D/ A.C.J.M), Jalaun at Orai from 22-11-23 to 31-03-2024.
2. The respected District Judge has recorded my overall assessment for the assessment year 2023-24 as "Good" without assigning any shortfall, inadequacy in judicial work or any specific reason during the said assessment year.
3. Whereas applicant has discharged his official duties with utmost sincerity & honesty as a result the applicant has achieved **1273.40 Units** out of 741.28 required units with a work percentage of **171.76%**.

4. Applicant has also decided total 9 execution cases out of which 2 were more than 15 years old and 2 cases were more than 10 years old, which is also mentioned in the remarks recorded by the respected District Judge.
5. Applicant has also decided number of old cases out of which **1 case of year 1995, 1 case of year 2002, 1 case of year 2005, 1 case of year 2006, 1 case of year 2008, 1 case of year 2010, 11 cases of year 2011, 4 cases of year 2012, 7 cases of year 2013, 5 cases of year 2014, 8 cases of year 2015, 5 cases of year 2016, 19 cases of year 2017**, which is also mentioned in the remarks recorded by the respected District Judge.
6. There has been no complaint of the applicant regarding the behaviour or judicial work, neither by the fellow judicial officers, nor by any members of the bar during the said assessment year.
7. There is no mention of any D.O or any adverse remark recorded by the respected District Judge in the self-assessment, neither the assessment recorded by the respected District Judge highlight's any inadequacy or irregularity in the work or the behaviour of the applicant during the assessment year.
8. Whatever duties & responsibilities had been assigned to the applicant by the respected District Judge or by Hon'ble High Court, the applicant has fulfilled it with all dedication and sincerity as a result the respected District Judge has also mentioned in the given remarks that "***The officer has also effectively worked as assistant Nodal Officer of training at District Head Quarter, delivered many lectures on different topics which enlightened the other judicial officers of the judgship. Officer has also effectively worked as a Assistant Nodal Officer of project "Suvaas" for hindi translation of Judgements of Hon'ble Supreme Court of India and Hon'ble High Court of Allahabad***". Above remark of the respected District Judge clearly reflects the seriousness & wholeheartedness of the applicant towards the tasks & duties assigned to him by his superior authorities.
9. Applicant has so far served for nearly 7 & ½ years in subordinate judiciary and has got appreciated service record and has never earned any displeasure from any of his District Judges or from the Hon'ble High Court.

With due regards applicant wants to submit that the overall assessment recorded by the respected District Judge mentions no Adverse remark against the applicant, neither it mentions or highlights any inadequacy or

irregularity in the behaviour or work done by the applicant in the said assessment year, on the contrary respected District Judge has highlighted the significant work done by the applicant and has mentioned the same in his concluding remarks. It is also worthy to mention that the respected District Judge has also rated the quality of judgements/orders passed by the applicant as A+ (Outstanding Category) in the assessment, despite above positive remarks & words of appreciation the "Good" entry recorded by the respected District Judge is highly discouraging & disheartening which is adversely affecting the morale of the applicant and the recorded entry can also be fatal for the carrier prospects of the applicant.

In the above circumstances it is, therefore, most humbly prayed that your goodself may kindly place this representation of mine before the then Hon'ble Administrative Judge of Jalaun Judgeship for his lordship's kind consideration. It is further prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment by upgrading the said entry recorded by the then respected District Judge, Shri Lallu Singh, in my ACR for the Assessment Year 2023-24. I shall remain grateful to the Hon'ble Court for this act of kindness & grace throughout my life.
