**Subject :** Representation against the remarks made by The District Judge, Rampur in Annual Confidential Report For Self Assessment Year 2023– 2024

Respected sir,

In respect of remarks of the Respected District Judge, Rampur made in column number **01(e)(iv) Progress and disposal of execution cases :- "No statement is attached regarding pendency and disposal of execution cases"**.

1- It is submitted that all kinds of files including execution cases in **The court of Additional District and Session judge (Fast Track Court), Rampur for trying cases of crime against women** period from 01.04.2023 to 18.11.2023 and **The court of Additional District and Session judge(Fast Track Court), Rampur under 14Th finance commission** period from 18.11.2023 to 31.03.2024 presided over by me were received by transfer on order of The Respected District judge. There were neither execution cases pending before April 1st 2023 nor any execution cases were received by transfer during these periods. Hence no statement regarding pendency and disposal of the execution cases were submitted along with the Self Assessment. Even The Respected District Judge, in his annual inspection of the Court done on dated 09.01.2024 and 10.01.2024 has himself **recorded that no execution cases were pending before the court.**

Hence it is clear that remarks made by The Respected District Judge, Rampur in column number **01(e)(iv)** performa of the Annual Confidential Report 2023–24, due to lack of correct information at the time of recording of the entry.

2- In respect of remark of the Respected District Judge made in column number **1(g)(iii) Number of civil cases decided on compromises/alternate dispute resolution; "As per statement, no cases decided"**

It is submitted that, then I was presided over **The court of Additional District and Session judge (Fast Track Court), Rampur for trying cases of crime against women** period from 01.04.2023 to 18.11.2023 and **the court of Additional District and Session judge(Fast Track Court), Rampur under 14Th finance commission** period from 18.11.2023 to 31.03.2024, As per pendency of cases where there were no compoundable case pending before these court except barring few miscellaneous cases. Since either parties were not willing to resolve the cases through Alternate Dispute Resolution by presenting such application or desired disposal on merit, there was no ground for resorting to mechanism of Alternate Dispute Resolution.

Hence it is clear that remarks made by The Respected district Judge, Rampur in these column too; is made without recognizing facts of the cases disposed. The remark is devoid of any merit and deserves for reconsideration.

Therefore, it is requested that my representation may kindly be placed before The Hon'ble Court. Further it is prayed that The Hon'ble court may, kindly be pleased to expunge the remarks made by The Respected District Judge, Rampur in the column number **01(g)(iii)** and column number **01(e)(iv)** performa of the Annual Confidential Report of 2023–2024.
