**Subject :** **Submission of representation against the overall Assessment in ACR 2023-2024 and up gradation of the same dated 23.05.2024.**

Respected Sir,

I most respectfully beg to submit my representation on the subject noted above as under :

1. In Annual Confidential Report point 1(a) my integrity has been mentioned as **beyond doubt** by Respected District Judge, Prayagraj.
2. I have also disposed 1301 cases which are more than 5 years old, 726 cases which are more than 10 years old and **89 cases of persons with more than 65 years of age** which has been mentioned as **79 cases of before year 2000** by Respected District Judge, Prayagraj in point 1(e) (iii) of ACR.
3. I have also achieved **2013.25 units** against required **701.44 units (which is 287.01% of the work done)** which has been mentioned in point 2 of ACR but Respected District Judge, Prayagraj has mentioned in point 1(g) of ACR that "as per the statement submitted by the Judicial Officer, the disposal of the work is adequate and percentage of work done is 167.77%."
4. My behaviour with brother officers and relations with members of the bar has been mentioned as **good**. Also I have been mentioned as **amenable** to the advice of the District Judge and other superior officers. I have been mentioned as **punctual and regular** in conducting judicial work.
5. The judgments passed by me has been deemed as well reasoned and properly narrated by Respected District Judge, Prayagraj in point 1(f) of ACR.
6. I also want to draw kind attention towards the fact that my percentage of work done in the year 2022-23 was 224.31% for which Respected District Judge, Shri Santosh Rai awarded me with "**Very Good**" rating and judgment/order writing capability was mentioned in the category A which is rated as '**Very Good**'. This year though my percentage of work done is 287.01% which is way more than the previous year, for which

Respected District Judge, Shri Santosh Rai has given “**Good**” rating and also judgment/order writing capability has been mentioned in the category B which is rated as “**Good**” whereas other fellow officers have received “very good” and “outstanding” ratings on similar basis. Also, Respected District Judge has not mentioned any adverse remark or has not stated any reason for which I have been given a ‘good’ rating whereas my fellow officers are entitled to ‘very good’ and ‘outstanding’ ratings. If some specific grounds had been mentioned on the basis of which other officers have received ‘very good’ and ‘outstanding’ rating it would have seemed as a guidance for the applicant to achieve better rating in future.


7. With all due respect I also want to state that this is my second posting, aforementioned rating will also affect my service career.

It is, therefore, most humbly prayed that your goodself may kindly place this representation of mine before the Hon’ble Administrative Judge of Prayagraj Judgeship for his lordship’s kind consideration. It is further prayed that the Hon’ble Court may be pleased to kindly consider this representation of mine and to upgrade my overall assessment recorded by the learned District Judge, Prayagraj, in my ACR for the Assessment Year 2023-24. I shall remain grateful to the Hon’ble Court for this grace throughout my life.
