Sir,

With due respect, I submit that I was posted as Additional District Judge in the Ambedkarnagar Judgeship during the year 2019 - 2020 and on 06.08.2020 I have taken over the charge of Principal Judge Family Court, Ambedkarnagar at Akbarpur.

In my Annual Confidential Remark, for the year 2019 - 2020, in entry number - 01(e)(iv) pertaining to disposal of execution cases "0" (zero) has been mentioned.

I was Presiding Officer of the Special Court Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act from 01.04.2019 to 31.10.2019 and on 31.10.2019 itself, I took over the charge of the Additional District Judge Court No.-1, Ambedkarnagar and remained Presiding Officer of Additional District and Sessions Judge Court No.-1 upto 05.08.2020.

There was no execution case pending in the Court of Special Judge Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act from 01.04.2019 up to 31.10.2019 ,that is, till the time of my handing over the charge of that court. In the Court of Additional District and Sessions Judge Court No.-1, also there was no execution case pending since the time of my taking over the charge that is 31.10.2019, upto the end of the financial year that is 31.03.2020. As column pertaining to execution cases was not given in the on-line proforma, therefore, information relating to execution cases was not mentioned by me in the on-line proforma.

Since no execution case was pending in the courts held by me during the time period 01.04.2019 to 31.03.2020, therefore, no execution case could be decided by me. Self attested photo state copies of the execution register of both the courts held by me during the my period as presiding officer of the respective courts are being annexed with this representation for benign perusal and consideration.

I, therefore, most humbly pray that in the above


