- 3. अधोहस्ताक्षरी की प्रशासनिक कार्यक्षमता, बार एसोसिएशन के सदस्यों से संबंध, महिलाओं के प्रति आदर एवं सेन्सटिविटी तथा वरिष्ठ एवं कॉनिष्ठ अधिकारीगण के साथ संबंध इत्यादि अच्छे है। ऐसा अंकन रिमार्क में श्रीमान जनपद न्यायाधीश, महोदय द्वारा स्वयं किया गया है।

- इस संदर्भ में यह उल्लेखनीय होगा कि प्रार्थी दिनांक 01.04.2019 से 15.04.2019 तक विशेष न्यायिक मजिस्ट्रेट आगरा के पद पर रहा जिसमें आपराधिक मामले लम्बित थे। कोई निष्पादन वाद लम्बित नहीं था तथा दिनांक 16.04.2019 से 29.07.2019 तक मुख्य न्यायिक मजिस्ट्रेट ललितपुर के पद पर कार्य किया गया। इस न्यायालय में भी आपराधिक मामले लम्बित थे तथा कोई निष्पादन वाद लम्बित नहीं था। पुनः पदोन्नति उपरान्त दिनांक 30.07.2019 से दिनांक 21.08.2019 तक (लगभग 21 दिन) अपर जनपद न्यायाधीश / फास्ट ट्रैक कोर्ट (महिलाओं के विरूद्ध अपराध) कानपुर नगर से संबंधित न्यायालय में कार्य किया गया। पुनः प्रार्थी का स्थानान्तरण अपर जिला एवं सत्र न्यायाधीश कक्ष सं0—10 कानपुर नगर के पद पर हो गया तथा दिनांक 22.08.2019 से दिनांक 31.03.2020 तक इस न्यायालय में कार्य किया गया। इस न्यायालय में कुल 7 (सात) निष्पादन वाद लिम्बत थे। जिसमें से 2 निष्पादन वाद माननीय उच्च न्यायालय से स्थगित थे तथा शेष 5 में से 01 निष्पादन वाद सं0-09/2019 मो0 अशफाक बनाम विशाल कुमार को सुनवाई के पश्चात अंतिम रूप से निर्णीत करने हेतु दिनांक 17.03.2020 को दिनांक 24.03.2020 के लिए संरक्षित किया गया, किन्तु आदेश होने से पूर्व कोविड—19 के कारण अचानक न्यायालय दिनांक 23.03.2020 से अनिश्चित काल के लिए बंद कर दिया गया जिस कारण दिनांक 24.03.2020 को निष्पादन वाद पर अंतिम आदेश पारित करना संभव नहीं था। इस प्रकार उपरोक्त परिस्थितियों के कारण निष्पादन वाद निर्णीत नहीं हो पाया था।
