Respected Sir,

With sincere regards, it is most humbly submitted that I am a direct recruit of examination of UPHJS 2018(part II) as Additional District and Sessions Judge, Court no. 10, Etawah . I joined Higher Judicial services under the Hon'ble Court's order at Etawah judgeship on 30.08.2019 and started discharging the judicial work as assigned to me by the then District Judge with immediate effect.

I have submitted my self assessment for the year 2019-2020 where I have received entries in my Annual Confidential Remark by the then District Judge on 28-09-2020 regarding which I take the liberty of making following submissions;

I. Column no. 1(g) of the ACR which concerns adequacy of the work disposed off records a shortage of 07.09% in achieving the target units. It is relevant to mention here that court No. 10 of which I took charge on 30.08.19 was lying vacant since 16.04.19. It is only after I joined that the files were transferred to this court. The files were not mature enough to yield any unit. It took me a while to ripen the files and make the court properly functional. Right after one month of joining, my on the job training/ dais training commenced from 30.09.19 to 11.11.19 and thereafter in continuity proceeded to induction training at JTRI, Lucknow from 15.11.19 to 14.01.20 under the orders of the Hon'ble Court. I resumed judicial work of the same court as earlier at Etawah Judgeship on 16.01.20. On 19.02.20 I was transferred to the court of ADJ-FTC-1 (for trying cases of crime against women) for a brief period of one month. On 19.03.20 I was again transferred back to the court of



Addl. District & Sessions Judge Court No.10. The frequent change of courts affected the effective and efficient running of my court working as well as my disposal of work. Chart reflecting the courts held by me is attached with this representation as **Annexure A.**

II. In column no. 01(g)(i) and 01(g)(ii) of the ACR the number of cases decided after actual full contest and the number of cases decided wherein all witnesses of fact turned hostile and the case ended in acquittal is recorded as 'NIL' which is not the case. I disposed off 10 contested matters and 14 matters otherwise. In total the disposal was of 24 matters as is evident from Annexure B.

A consolidated chart of work done by me in the entire period of assessment is enclosed with this representation as **Annexure C**.

III. Column no. 01(e)(iv) progress and disposal of execution cases records 'Nil' as remark. I most graciously submit that I disposed off two uncontested **arbitration** executions out of total 61 arbitration executions pending in my court. As stated earlier due to frequent change of courts and limited number of effective work days I could not dispose off more. **Annexure D** is on record for ready reference.

During the brief stint of my service, the effective working days were 67 and the target units were 219.76 out of which the achieved units were 204.20 as is evident from Annexure E. I would most humbly like to bring this fact to the fore that I am a fresh incumbent in the service and despite having a very few actual working days, I left no stone unturned to meet the stipulated targets albeit missed it by a very small fraction, which i will ensure as completed in future.

I therefore with utmost sincerity request your good self to kindly place my representation before the Hon'ble Court for Their Lordship's kind consideration and upgradation of my Annual Confidential Remark.
