**Sub: Representation on the award of entry by the then District Judge, Mau,
Shri Mukesh Mishra in the ACR for the year 2019-2020.**

Respected Sir,

1. Most humbly, I request you to please be kind enough to place my Representation regarding the Captioned subject before his lordship, the Hon'ble Administrative Judge, Mau
2. Most humbly, with due respect and a heavy heart I beg to submit my representation against the Annual Confidential Remark (ACR) for the year 2019-2020 awarded to me by the then Respected District Judge, Mau, shri Mukesh Mishra.
3. Sir, I have been awarded "Good" In my ACR, which I believe is not based upon fair evaluation.
4. During the assessment period I.e. during the period 01/04/2019 to 31/03/2020 I presided over the court of civil judge junior division, Sadar, Mau till 18/01/2020 I.e for about 10 months. It was purely a civil (Parent) Court. Since 18/01/2020 I have been appointed as full time Secretary, DLSA, Mau. During the assessment period No criminal court was presided by me.
5. In these 10 months I have worked with commitment, honesty and integrity. The Respected District Judge has acknowledged the same in his remark.
6. In the said period I have disposed Numerous old cases of all categories, including contested Original suits, Contested Miscellaneous Suits and Contested Execution cases. As per the records I have disposed 102 cases through Lok Adalat/ADR. But due to clerical Mistake/otherwise the ACR entry by the Respected



District Judge mentions only 61 cases as disposed on compromise/ Alternate Dispute Resolution. The pendency of cases in the said court was considerably brought down. Also, The actual units achieved by me is more than double the units required in the said assessment period.

7. Further, I have actively discharged my duties even in administrative capacities like member of infrastructure sub committee and officer-in-charge C.C.Amin. In absence of officer in charge Nazarat, I have also performed my duties as Additional officer incharge Nazarat.

8. All the above facts/ figures have been mentioned by me in my self assessment report and all the above facts and figures have also been acknowledged by the then District Judge, Mau.


9. None of the parameters as mentioned in the various columns of the ACR in respect of which I was to be assessed were found lacking NOR there is any adverse remark in my ACR. Inspite of fulfilling all requirements as mentioned in the Self Assessment Form, and working hard and achieving outstanding work/disposal, the overall assessment has been marked as "Good" by the Respected former District Judge, Mau, which I believe is done very casually, without actually appreciating my performance on merit and therefore is not a fair evaluation of my hard work. Such casual remarks results in hopelessness, despair and disappointment to the concerned officer. The then Respected District Judge, Mau has totally disregarded and overlooked my performance leaving me pained, demoralized and demotivated.

Therefore, I most humbly and respectfully submit to your kindness to please re-evaluate my performance in the year under assessment and bless me with the rating which I honestly and truly deserve. A kind and generous award by his Lordship to my rating would energise, motivate and boost me with more commitment, enthusiasm and positivism towards discharging my responsibilities and will surely strenthen my faith on honest hardwork.
