Respected Sir,

The applicant most humbly beg to submit that the remarks given by the District Judge in Annual Self Assessment for the year 2019-2020, Case ID- 598 was communicated to the applicant through online portal on 14.12.2020.

The applicant most humbly beg to submit following facts and circumstances regarding above subject for kind consideration before the Hon'ble Court/ Administrative Judge-

1. That it is submitted with all due respect that the applicant humbly represent against the remarks given by the District Judge Shri Prem Nath Sir in the column no-2 of the ACR, regarding overall assessment of the merit of the officer wherein the applicant have been awarded "Good" entry by the respected District Judge.
2. That my respectful submission is that in the year 2019-20, it has been recorded that the applicant had achieved 1720.37 units against the target of 1066 units, which is 161.38 % and much above the target units. It is pertinent to mention that the applicant was provided with the stenographer since month of December 2019 till end of the assessment year i.e, March 2020 and not before that.
3. That my respectful submission is that the details of the old cases decided by the applicant was also recorded by the District Judge. From amongst the oldest cases disposed, 2 of them were more than 15 yrs and 20 yrs old. The applicant has

decided 7 fully contested cases. The respected District judge has also observed that the applicant disposed off 38 cases on the basis of Compromise and ADR. The applicant got the opportunity to attend 2 Lok Adalats in which 23 cases were disposed off. The applicant had put forth all the efforts in disposing the pending Final Reports in her court which were around 190 cases, out of which the applicant successfully managed to dispose off 129 Final Reports in the assessment period. The applicant has sincerely strived for complete and proper updation of around 6000 files on CIS pending in the court and has fortuitously attained the same.

4. That my respectful submission is that in the year 2019-20, the applicant was in continuous In chargeship of various other following Courts from February 2020 to March 2020:-

- In charge of the Court of Chief Judicial Magistrate.
- In charge of the Court of Additional Chief Judicial Magistrate.
- In charge of the Court of Additional Chief Judicial Magistrate (F.T.C).
- In charge of the Court of Judicial Magistrate.

And also the applicant was entrusted with various responsibilities through undermentioned administrative charges /offices / membership by the District Judge:-

- Officer in charge of Inspection Department.
- Officer in charge of Copying Section.
- Member, District Court Computer Committee.
- Member, Promotion committee, Selection committee, Purchase committee.
- Member of Civil court staff centralised recruitment committee and member of committee for preparation of Advocate roll, I.D, Vehicle pass etc.

Apart from this, the applicant worked hard and with full devotion for successfully completing the Judicial as well as administrative work from time to time, which has also been observed by the respected District Judge in the ACR.

5. That it is submitted with all due respect that the applicant during the assessment year 2019-20, was undergoing training and had went to J.T.R.I Lucknow for Induction training 2nd phase from August 26th 2019 to October 26th 2019.


Kindly place my respectful submission before Hon'ble Court/ Administrative Judge for kind and sympathetic consideration.
