Subject- Representation against adverse remark recorded by the then
District judge in my Annual confidential Remark for the
Assessment year 2019-2020.

Respected Sir,

Most humbly and respectfully submitted that the annual confidential remark for the assessment year 2019-20 has been communicated to me on 29-01-2021 vide Letter no. 109(2)/MACT/2021/Bijnor dated 16/01/2021 by the then District Judge Mainpuri, Presently posted as Presiding officer Motor Accident claim tribunal Bijnor whereby his good self has recorded my overall assessment remark assessment year 2019-20 as "Poor".

In this context I humbly submit as under : -

(1) In column no 01 (a) of ACR which deals with integrity the then Respected District Judge has recorded integrity "Positively lacking, murmuring Bar and public". In this context, It is most humbly submitted that prior to this remark no oral or written warning was given by the then respected District judge at any point of time. It is further pertinent to mention that in my service of 16 years my integrity has always been certified beyond doubt. I have to humbly submit that I had never done anything in my service career which has lowered the dignity and honour as well pioussness of the service. The aforesaid adverse remark given by the respected District Judge does not find any support by any complaint/record whatsoever.

(2) In coloumn no 01 (e) (iv) the "progress and disposal of execution cases is mentioned as nil" so far as the above remark is concerned it is most humbly submitted there was no execution cases pending in my court during the aforesaid period.

(3) In column no 01 (m) it has been mentioned that " Officer formed groupism against District judge". In this context it is most humbly submitted I have not done any such act and all the works and responsibilities assigned to me by the then respected District Judge has been done by me with utmost responsibilities. I was always committed and devoted for the institution. I maintain and still maintain cordial relation

with all officers. Prior to this remark the then respected District judge has never shown any dissatisfaction about this.

(4) In column no (02) it has been mentioned that "overall assessment is poor" In this regard it is most humbly submitted that my judicial work has been found to be adequate by the then respected District judge and I have achieved 2106.33 unit against the target unit 1200. It is further pertinent and noteworthy to mention that the then respected District judge has himself observed that "I am fair and impartial dealing with public & bar". I have been found by him to be cool minded and does not lose temper in court. Nothing has been found against my private character, my control over the files have been found proper. Performance with regard to decision of motor accident claim related to Death/injury has also been said to be good. My judgment on fact & law has been recorded by the then respected District judge, sound, well reasoned and expressed in good language. I have been rated as a punctual officer and have disposed adequate old cases with taking interest. It has also been mentioned by the then respected district judge that my control over the office and administrative capacity is good and i maintained cordial relation with member of Bar and Brother officer. Apart from this this i have to submit respectfully that during my whole past service not even iota of any adverse remark had ever been recorded by any of the then District judges. Last but not least it is again reiterated that the applicant respect the system from core of the heart and never think of doing any such thing which let down the respect and honour


of the system. Thus in light of all the above fact, the over all assessment of mine as poor, be expunged and deserve to be upgraded.

Therefore, I most humbly request with folded hand that my representation may kindly be placed before the Hon'ble court for kind and sympathetic consideration with a request to expunge the adverse remark given by the then respected District Judge in my ACR and upgrade it, for which applicant shall feel obliged for ever.
