Sir.

With reference to the above captioned subject, I beg to submit that annual confidential remarks for the year 2019-2020 recorded by the Presiding Officer Motor Accident Claim Tribunal, Bijnor, the then, District Judge, Mainpuri vide Letter No. 109(19)/ MACT /2021/ Bijnor was communicated to me on 25.01.2021.

In the annual confidential remarks in the column 01(e)(iv) regarding progress and disposal of execution cases, it is recorded that out of 13 executions 04 were stayed and no execution was decided.

In this respect, I humbly wish to submit as under:-

That Pendency of execution cases on 01.04.2019 was shown as 14 in the annexure attached with the self assessment. Out of these 13 were petitions U/s 174 M.V. Act (Recovery Cases) which do not come under the ambit of execution under order XXI C.P.C. as these are the miscellaneous applications and only one case was execution under order XXI C.P.C., the proceedings of which were stayed by the Hon'ble High Court.

Mo-Moloway

That in the aforesaid 13 cases of section 174 M.V. Act, endeavour was made to dispose the cases, but in the meanwhile these cases were transferred to the Motor Accident Claim Tribunal.

That during the financial year 2019-2020. 03 executions under order XXI C.P.C. were received by transfer. The proceedings of all these 03 cases were already stayed by the Hon'ble High Court.

That on 04.10.2019 an execution for ex parte decree was instituted in my Court, in which process were issued but were not served till 31.03.2020. Needless to say that this execution was in a very premature stage.

It is noteworthy to put to the knowledge of kind self that at the end of the financial year 2019-2020, there were 05 pending execution cases out of which 04 were stayed by the Hon'ble High Court. The current status regarding the stay order was not available on the official website of the Hon'ble High Court and correspondence regarding the same was made but no information was received till 31.03.2020. The remaining one execution was in a very premature stage, process were issued but were not served hence could not be disposed till 21.03.2020. Thereafter the court functioning remain suspended due to Covid 19 pandemic. Annexure is attached for the perusal of kind self.

In view of the above, it is humbly submitted that despite my due efforts and endeavour the execution cases were not decided as 04 cases were stayed by the Hon'ble High Court and one case was a fresh institution and was in the initial stage of proceedings.

Therefore, I humbly request to place my representation before the Hon'ble Court for kind and sympathetic considerations and expunge the adverse remark with respect to execution in column No. 01(e)(iv) of annual confidential remarks 2019-2020.
