Subject:- Representation against adverse remark recorded by The Learned District Judge in my Annual Confidential Remarks for the year 2019-2020. (Case id no. 2164)

Sir,

It is humbly submitted that Annual Confidential Remarks for the year 2019-2020 given by the then District Judge Sir was communicated to me vide Letter No. 109(7) / MACT / Bijnor on date 25-01-2021. In the column No. 2 of Annual Confidential Remarks for the year 2019-2020, The then District Judge Sir has awarded me with "**Good**" entry, But in column no. 01 (e) (IV) where progress & disposal of execution cases is asked, it has been recorded by the District Judge Sir that - no execution is shown to have been decided.

In this regard, it is to be humbly submitted that I have annexed the statement of year wise breakup of cases in column 7 of my self assessment for year 2019-2020. The statement clearly reveals that during the period of 01-04-2019 to 31-03-2020 **3 Execution Applications were decided by me**. Copy of statement of institution, pendency and disposal of cases are being enclosed as Annexure no. 1&2 for kind perusal.

Thus, it appears that inadvertent factual mistake has been made by

the then District Judge Sir in recording the fact that I have not decided any Execution application & Perhaps due to this reason, the then District Judge Sir recorded "**Good**" entry as my overall assessment.

I humbly beg to bring to your kind notice that in column no.1(g) of Annual Confidential Remarks for the year 2019-2020, It has been recorded that I have given an out turn of 2538.58 Units against 1200 Units during the whole year.

Apart from it, I also contributed in administrative work which was entrusted to me. I was Officer Incharge Amins, Incharge of Court of Civil Judge (S.D.) / F.T.C. and member of Committee for Appointment of Oath Commissioners, Committee for appointment of General Commissioners, Committee for Appointment of Survey Commissioners, Committee for Implementations of Action Plans, Complaints Committee for Prevention of Sexual harassment of women at workplaces & Committee for Redressal of Grievances. Thus, it is my humble submission that "Good" entry does not properly justify the efforts which I have put in Judicial and Administrative work during the assessment year.

Therefore, I most humbly submit that the above mentioned facts may kindly be considered and it may kindly be recorded that I have decided 3 Execution Applications. Moreover, "Good" entry in Column no. 2 regarding overall assessment may kindly be upgraded to any other higher suitable entry which the Hon'ble Court deems fit.

It is requested that my submission may kindly be placed before the Hon'ble Court for kind and sympathetic consideration.
