With due respect and utmost humility, I beg to submit that vide letter No. 109 (5) /MACT /2021/ Bijnor dated 16/01/2021, the Annual confidential Remarks for the year 2019-2020 recorded by the Presiding officer, Motor Accidents claim Tribunal, Bijnor, the then District Judge, Mainpuri were communicated to me on 27/01/2021. Wherein, the overall assessment of the merit of the officer was recorded as "average".

In this regard, I humbly submit as under:-

1. That with respect to entry regarding column no 01(e) (iii) viz Disposal of old cases, it is recorded that the officer has not submitted the year wise break up of the whole year. She has only submitted the statement of the month of March 2019 in which only 05 oldest criminal cases are shown to have been disposed as special Judge/EC Act, Mainpuri.

In this regard, I wish to put to the knowledge of kind self that in the column No. 2A(ii) of the self assessment it has been mentioned that the disposal of cases which were more than 5 Years old was 29 and in column no.2B(ii) it has been mentioned that disposal of old cases which were more than ten years old was 22 .The Respective pendency as Target and Achievement as disposal is mentioned in the self assessment while holding various courts during the said financial year. The statements showing the disposal of five years old and ten years old cases by me while holding various courts in the year 2019-2020 is annexed along with for the kind perusal of good self.

2. That regarding entry in Column No 01(g) viz whether disposal of work is adequate, it has been recorded that during the whole year 2019-2020, the officer remained posted as ACJM RaeBareli, ACJM BulandShahar, CJM BulandShahar, ADJ/FTC Jalaun at Orai , ADJ/FTC I Mainpuri , ASJ(Court no.8) Mainpuri but the officer has only submitted the work done of ADJ/FTC-I Mainpuri from 22.10.2019 to 18.03.2020 and during this 5 months, She has given an out turn of 534.23 units . She has not submitted the out turn of rest period , so the out turn is not adequate.

In this regard, I humbly submit that I have achieved the units of 1574.37 in the financial year 2019-2020. It is noteworthy to mention that I held the court of ACJM Raebareli from 01/04/2019 to 15/04/2019 wherein total units achieved were 95.95 units. Thereafter I was transferred to Bulandshahar as ACJM. Thetotal units achieved as ACJM Bulandshahar from 16/04/19 to 31/07/19 were 622.59. Thereafter I took the charge of CJM Bulandshaharand the units achieved as CJM Bulandshahar from 01/08/2019 to 24/08/2019 were 131.36. I was then promoted and transferred to Jalaun as ADJ/FTC wherein 190.24 units were credited on account of child care leave. Thereafter I was transferred to Mainpuri where I took charge of ADJ/FTC on 22/10/2019 and held the court till 18/03/2020. During this period total units of 534.23 were achieved by me. I was then directed to hold the charge of

ASJ/Court No. 8 on 19/03/2020, and the work remained suspended due to pandemic since 22/03/2020. Statements showing the units achieved by me in 2019-2020 while holding various courts is annexed along with for the perusal of kind self.

That with respect to entry regarding number of cases decided after full contest in column no. 01(g)(i) it is recorded as NIL

As far as the above remark is concerned it is very humbly submitted that while holding the court of ADJ/FTC from22/10/2019 till 18/03/2020 total 22 cases have been disposed by me . The copies of five contested judgments have already been annexed along with the self assessment which in itself is self explanatory. The statement showing the disposal as ADJ/FTC is annexed along with for the kind perusal.

In view of the above, it is humbly requested that my submissions be placed before the Honb'le Court for kind and sympathetic consideration with a humble request to reconsider and expunge the critical remarks and substitute that with the appropriate entry in my Annual Confidential Remarks for the year 2019-2020.
