**Sub: Submission of Representation against the only adverse remark by the then Ld. District Judge, Ghaziabad in the ACR of the undersigned applicant regarding control over the office and Administrative capacity and tact during the Assessment year 2020-21 as communicated through e-services online portal on 27-02-21**

Sir,

I most respectfully beg to submit my Representation on the subject noted above as under:

1. That during the Assessment year 2020-21 I worked as Additional Principal Judge (Family Court), Ghaziabad from 01-04-20 to 16-10-20 and Additional District and Sessions Judge Court No-3, Ghaziabad from 16-10-20 to 31.01.21. (Assessment is made for period dated. 01-04-20 to 31-01-21).
2. That during the Assessment period the learned District Judge, Ghaziabad who except in column no- 1(h) of Assessment remarks regarding control on the office and Administrative Capacity and tact has appreciated my work and performance with overall assessment of mine as 'Good'. However in column No-1(h) of Assessment remarks the learned District Judge has recorded his observation as 'Average'. It is humbly submitted that the above observation of the Ld. District Judge on control over office and Administrative capacity is factually incorrect as no incident respecting any such observation ever happened during the Assessment period nor any remark was ever communicated to me by the Ld. District Judge during the Assessment period.
3. That is also pertinent to specify that no such remark regarding control over office and Administrative capacity has ever been recorded against me by any authority during the last 12 years of my Judicial services.
4. That during the Assessment period 2020-21 the Judicial work was paralised due to covid-


19 Pandemic and normal Judicial work resumed from 02-01-21. In spite of covid-2019 lock-down and consequential restricted work the officer has been able to achieve the required target which has been appreciated by the Ld. District Judge in column no-1 (g) with observation that "As against target of 1000 units the officer has given out turn of 1055.55 units which is above the prescribed target. Since April 2020 to Dec 2020 Judicial work was paralised due to covid-19 and the officer has tried his best to achieve the target". Apart from it, I have also contributed in administrative work which was entrusted to me. I worked as officer In-charge library and stationary and In-charge Security court campus. The Ld. District Judge has also recorded that the officer is fair and impartial and is amenable to advice of the District Judge and other Superior officers.

It is therefore, humbly requested that your goodself may kindly place the representation of mine before the Hon'ble Court. It is most earnestly prayed by me that the Hon'ble Court may be pleased to kindly consider my this representation and expunge the only above adverse remark on control of office and Administrative capacity and tact recorded by the Ld. District Judge, Ghaziabad for Assessment year 2020-21 and the overall assessment may kindly be upgraded to any other higher suitable entry which the Hon'ble Court deems fit. I shall remain grateful to the Hon'ble Court for this grace throughout my life.
