Subject- Submission of representation against remarks recorded by Sri M.A.H. Idrisi, the then District Judge Unnao in the assesment year 2019-2020

Sir,

I most respectfully submit my representation on the subject noted above as under:

It is Humbly submitted that during assessment year 2019-2020, I was posted as Additional Chief Judicial Magistrate Court No. 1 Unnao from 01-04-2019 to 31-07-2019, while working as A.C.J.M. 1, I also worked as Principal Magistrate Juvenile Justice Board, then after from 01-08-2019 to 31-03-2019 I held the Court of Civil Judge (senior Div.) Unnao

1. During that period Sri M.A.H. Idrisi was the learned District Judge Unnao, who has sent his report on the Self-Assessment form and recorded entries in my A.C.R. for the said assessment year 2019-2020, thus: "Integrity beyond doubt, fair and impartial in dealing with the public and the bar, cool-minded, does not loose temper in the court, private character is not of such as to lower in the estimation of public or adversely affect the discharge of offical duties, fixing of cause-list proper, sufficient number of cases fixed to

keep engaged during full court hours, avoid unnecessary adjournments to expedite disposal of cases, the quantum of work is sufficient and adequate, good administrative control over Court's office, tactful officer, possesses good administrative capacity, relations with Bar are cordial, commands deep respect from the Bar, relations with brother/sister officers are cordial and behavior with them is polite and humble, inspections of court and offices are full and effective, punctual and regular in sitting on the dias during court hours, amenable to the advice of district Judge and other superior officers, respectfull and polite towards women and shows sensitivity towards them while hearing their cases and otherwise too, and in ther remarks, he recorded that officer is hard working, possesses good knowledge of law, displays administrative capacity and tactfulness, work behaviour and conduct displays a good judicial officer, overall assesment of the officer-'good'.

2. As to the remark recorded in column no. 1(e)(iv) that is progress and disposal of execution cases, the learned District Judge has recorded the remark **"The yearwise break up of pending cases submitted in the form of statement by the officer exhibit a total number of 50 execution cases. Out of these cases officer has disposed of only 02 execution cases. In view of the pendency of execution cases, she is advised to do more execution cases."**

It is humbly submitted as to the remark recorded by the District Judge that the yearwise breakup of pending cases submitted by me in the

form of statement shows the pendency as on 01-08-2019 there were 35 execution cases (Including 09 cases stayed by Hon'ble High Court) in total, to which District Judge has shown 50 execution cases in the remarks recorded by him.

Out of the pending execution cases the District Judge has shown in his remarks that I have disposed only **02 execution cases**, in this regard I respectfully submit that I have disposed **05 execution cases** in total (04 Civil execution and 01 P.A. Execution cases). Further I respectfully beg to submit that I have made all possible endeavours to dispose more execution cases and shall also continue to do the same.

The statement of pendency and disposal of execution cases attached by me at the time of submitting my Self-Assessment for the year 2019-2020 is hereby submitted for kind perusal.

3. 01(e)(v)- With regard to the temporary injunction applications remark recorded by the then learned District Judge regarding disposal is **"Officer has not furnished any statement/list of cases and copies of orders passed on injunction-granted, refused or retained and why. She has not Provided any number of such application which could be examined. Thus, information available is incomplete and not sufficient to be examined the date pertaining to query."** In this regard I respectfully beg to submit that in the self-assessment form provided on the e-services J.O. portal, there was no separate column to attach details or statement regarding

this.

Further I have to submit that the details of disposal of temporary injunction applications has been shown by me in the **proforma 16A** attached by me while submitting my self assesment for 2019-2020.

4. 01(f)- The remark recorded against me by the then learned District Judge with regard to this cloumn is that "**Although the officer has mentioned in her Self-Assessment Application delivery of three judgments namely case R.S. no. 260@17 Chandravati v/s Ramkumar, Cr. no. 800/2005 State v/s Madan Singh and others, Cr. No. 3714/2017 State vs Lallan, but no copy of any judgement is submitted and for further details/mode or e-mail data to obtain these judgements from internet.**" In this regard I respectfully beg to submit that I had attached copy of three contested judgments and also uploaded the same judgements on portal which are still shown on J.O. portal at the time of submitting my self-Assessment for assessment year 2019-2020. I am re-attaching the copies of three judgments annexed by me earlier with my Self-Assessment for your kind perusal.

8. 01(g)(i)- As to the remark recorded in column no. 1(g)(i), that is number of cases decided after actual full contest, the learned District Judge has recorded the remark "**Officer has decided 01 case after full contest**" in this regard I respectfully submit that I have decided **36 cases after actual**

full contest in total, out of which 14 cases were disposed in the Court of ACJM-1, 21 cases in J.J. Board and 01 Case in the Court of Civil Judge(Sr. Div.).

The complete statement regarding the above said field (**Proforma 16A at serial no. 3 and proforma 16B**) has been attached by me in my Self-Assessment at the time of submitting the same.

9. 01(g)(iii)- As to remark recorded in the column no. 1(g)(iii) regarding number of civil cases decided on compromise/alternate dispute resolution.

In this regard I respectfully beg to submit that with my Self-Assessment 2019-2020, in part-1 of that form at **point no. 16**, I have expressly mentioned the disposal of **20 Civil** and 256 Criminal Cases by me, **instead of 11 Civil** Cases as shown by the then learned District Judge in the remarks recorded by him.

The complete information regarding this point has been filled by me in that column (**i.e. point no. 16 performance in Lok Adalat**). Details as provided earlier, while submitting Self-Assessment form 2019-2020 are hereby attached for your kind persual.

It is, therefore, most humbly prayed that your good self may kindly place this representation of mine before the then Hon'ble Administrative Judge of Unnao Judgeship for his/her Lordship's kind consideration. It is further prayed that the Hon'ble court may be pleased to kindly consider this representation of mine and make my proper assessment by expunging the aforesaid remarks as recorded by the then Learned District Judge Unnao in
