Subject:- Submission of representation against remarks recorded in column 1(e)(iv) & 1(e)(v) by Sri M.A.H. Idrisi, the then District & Sessions Judge, Unnao, as to little short disposal of execution cases and non furnishing of statement of interim injunction in assessment year 2019-2020, as communicated vide E-Services J O Portal.

Sir,

I, most respectfully beg to submit my representation on the subject noted above as under:-

1. That, during the assessment year 2019-2020, I was posted as Civil Judge (S.D.) FTC at Unnao, and during that period Sri M.A.H. Idrisi was the then learned District Judge, Unnao who has recorded entries in my A.C.R. for the said assessment year 2019-2020 thus: “ Integrity beyond doubt, fair and impartial in dealing with the public and the bar, officer is cool- minded, does not lose temper in court, private character, is not such as to lower her in estimation of public or adversely affect the discharge of her official duties, fixing of cause-list proper, cases are so fixed that old and other important cases be disposed off on priority basis, sufficient number of cases fixed to keep busy and engaged during full court hours, unnecessary adjournments- avoided to expedite disposal of cases, the officer has decided a good number of old cases, performance is satisfactory in this regard, a perusal of judgments attached with self- assessment form go to show that officer has mastery over the facts, good balance between them, appreciation of evidence is good, judgments on facts and law on the whole are sound, well-

reasoned and expressed in good language, marshalling of facts- good, appreciation of evidences- good, application of law- good, percentage of work is adequate, officer has good administrative control over court's office, tactful, possesses administrative capacity, relations with members of the bar- cordial, relation with brother officers- polite and humble, inspections are full and effective, punctual and regular in sitting on dais during court hours , amenable to the advises of district Judge and other superior officers, behavior towards women- respectful and polite towards women and shows sensitivity towards them, overall assessment of the merit of the officer- **'good'**, other remark- good administrative capacity and tact in dealing with Bar and general litigants".

2. That the remark recorded by the said , the then learned District Judge, Unnao , against me in the assessment year 2019-2020 **in column 1(e)(iv) progress and disposal of execution cases is** , that officer has furnished year wise break up that shows 41 execution cases were pending from year 1973 to 2020. She has disposed only 04 execution cases i.e. 1 case of 2012, 1 case of 2014, 1 case of 2016 and 1 case of 2017 . Keeping in view the no. of pendency of cases and duration of the court held by her, disposal appears a little short. She is advised to do more execution cases.

In this regard, I respectfully beg to submit that in abovesaid assessment year I have in fact disposed 5 execution cases instead of 4 cases, i.e. 4 reg. execution cases(1 case of 2012, 1 case of 2014, 1 case of 2016 and 1 case of 2017), and 1 SCC execution case of 2017, which are also shown in the statement attached by me while submitting my self-assessment form.

It is further most respectfully submitted that I have made all the possible endeavours to dispose of more such cases by issuing amin parwanas in approximately 5 cases to amin for fulfilment of execution, but due to various reasons amin did not send his report and sought adjournments. During the assessment period I was also assigned with

criminal work and Negotiable Instruments Act cases of whole district. In the assessment year 2019-2020, I remained on child care leave for 52 days, my actual work days were 188 days, in which I had given 153.17% quantum of work.

3. That the other remark by the said, the then learned District Judge, Unnao, in column 1(e)(v) is that, officer has not furnished any statement copy of order about interim injunction orders granted, refused or retained and why. Thus information furnished is not sufficient to make any comment. In this regard I respectfully beg to submit that in the self- assessment submission form, there was no column to requiring to attach separate statement regarding this. The details were, however, shown in the attachment provided by me with point no.15 of the application for self assessment.
4. It is, therefore, most humbly prayed that your good self may kindly place this representation of mine before the Hon'ble Administrative Judge of Unnao Judgeship for his/her Lordship's kind consideration. It is further prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment by expunging the aforesaid remarks recorded by the then learned District Judge Unnao, in my A.C.R for the assessment year 2019-2020. I shall remain highly grateful to the Hon'ble Court for this grace throughout my life.
