Respected Sir,

The applicant humbly submits as under ----

1. The remark of above-mentioned year given by the respected District Judge was communicated to applicant through e-portal on dated 09.07.2021.
2. The applicant submits that in column no 2 i.e. Overall assessment of the merit of the officer, in which applicant was awarded "GOOD" remark by the respected District Judge.
3. The applicant wants to bring to your kind attention that in his remark the respected District Judge has nowhere mentioned anything adverse about applicant's integrity, work, conduct, character, knowledge or punctuality. In fact, it is recorded that applicant achieved 2003.63 Units against targeted units 581.90 which are far beyond than desired units. The percentage of work done of applicant is 344.32%.
4. The applicant further submits that he decided number of oldest cases which was also recorded by the respected District Judge. Apart from it, in the very assessment year applicant had the charge of Principal Magistrate, Juvenile Justice Board in which applicant decided enormous number of oldest cases of the year of 1987, 1991, 1993, 1997, 2001 etc.

5. The applicant humbly conveys that applicant holds the charge of Civil Judge (Senior Division) on 26.03.2021 to 31.03.2021. In such a short span, applicant decided one Execution case at full satisfaction.
6. The applicant further conveys that in National Lok Adalat, 186 cases have been decided by applicant. It is pertinent to mention here that in assessment year of 2020-21, only two National Lok Adalat were organized.
7. The applicant brings to your kind notice that in spite of Covid-19 pandemic and limited functioning of court due to Covid-19 protocol, applicant achieved 344.32% units and disposed a large number of cases including old and oldest category.
8. It is noteworthy to mention here that respected District Judge remarked "Very Good" in Column no. 1(f) about appreciation of evidences, application of law and control over office and administrative capacity.
9. The applicant very humbly submits that "GOOD" entry does not justify the efforts of applicant which he puts in his work during the very assessment year.


PRAYER
