Respected Sir,

The undersigned is praying to submit the following facts regarding the annual confidential remark of the undersigned given by The Principal Judge, Family Court, Kanpur Nagar for the year 2020-21.

- 1- The undersigned was required to give 1200 units for the total required work, mentioned at the point number 2 on its own assessment, while the undersigned has achieved 1658 units of the work done.
- 2- The undersigned has decided 2 cases older than 10 years of section 13(H.M.Act) and 9 cases u/s 125 Cr.PC and 128 Cr.PC.(Total 11 cases out of 15), in which 5 cases were decided on merit after actual contest. Apart from this, only four case of more than 10 years old pending in the court, in which one case is stayed by the Hon'ble High Court. In this way, most of the cases which are more than 10 years old have been disposed off by the undersigned.
- 3- A total of 21 cases have been decided by the undersigned on merit after actual contest.
- 4- Two cases of persons over the age of 65 year were pending in the court of the undersigned, in which one case has been decided by the court.
- 5- A total of 31 cases have been decided by the undersigned through the Lok Adalat/ Alternative Dispute System. Case no. 833/2020 (Beena Vs Sanjeev, U/S 13-B, H.M.A.), in this case special effort was made by the court and in result presently both parties are living togather.
- 6- A total of 17 execution cases were pending in the court of undersigned, 8 execution cases were decided by the court, in which 3 cases were decided in full satisfaction.
- 7- The administrative work capacity, relation with the members of the Bar Association, respect and sensitivity toward the women, and relationship with senior and junior officers etc. of the undersigned is "Proper, Cordial and Good" respectively. This mark of favor has been done by The Principal Judge, Family Court himself.
- 8- In para 1(f) of the application for assessment the judgement of the undersigned were found "On fact and on law are on the whole sound, well resoned and expressed in good language? To answer this question The Principal Judge, Family Court, has himself remarked as "Yes".
- 9- In para 1(k) of the application of assessment it is mentioned that the officer has made regular inspection, but learned Principal judge, Family Court has not commented on the point that "whether such inspections were full and effective?", where as I have

inspected my office thoroughly and effectively.

10- It may not be out of taste to mention here that Hon'ble High Court by letter no. C – 671/CF(B)/2021: Dated: Allahabad: July 17,2021, has been exempted/relaxed in the QUOTA/UNITS prescribed for the Judicial Officers for the assessment year 2020-21 keeping in view the pandemic of COVID-19.

Keeping in view the judicial work, behavior and conduct of the undersigned and remrks given by Learned Principal Judge, Family Court it was necessary to submit a report to upgread the remarks "Good" given by The Principal Judge, Family Court to it's overall assessment in column no 2.

Prayer

Therefore It is humbly requested to upgrade the remarks "Good" given by the Learned Principal Judge Judge, Family Court to its overall assessment in column No.2.

It is humbly submitted that the representation be presented before the Hon'ble Court for kind consideration.
