Sub. Representation against "Average" Remarks given by the District Judge, Sitapur in my Annual Confidential Remarks for the Assessment Year 2020-2021.


Respected Sir,

On the above noted subject, it is humbly submitted that during the Assessment Year 2020-2021, I was posted as Addl. District Judge, Sitapur. Regarding "Average" Remarks given by the District Judge, Sitapur for the Assessment Year 2020-2021, it is humbly submitted that:-

1. From 01.04.2020 to 07.05.2020 the courts were totally closed due to Covid-19 Lockdown (without physical hearing) and from 08.05.2020 to 07/08.01.2021 only urgent work was permitted by the Hon'ble High Court (without physical hearing) and regular works, with physical hearing , were suspended.

2. It is also requested that from 01.04.2020 to 07.01.2021 the Officers were directed to leave the court premises after completion of their work. I have followed the direction of Hon'ble High Court and Government order as passed from time to time to attend the court during Covid-19. After completion of work I had left court premises following the directions in true letter and spirit, as per roster scheduled by respected District Judge.

3. Respected District Judge himself has opined in Para



1(m) positively as amenable to the advice of the District and other superior officers but concluded contrary to the above fact in over-all assessment that the Officer is not amenable to the District Judge.

4. It is pertinent to mention that I have stated in Para-6 of my Self-Assessment that I had discharged the work of so many sections which are-(1) Chairman District Court Computerization Committee Sitapur, From 02.02.2021 to 31.03.2021, (2) O/C. General Administration Sitapur, From 02.02.2021 to 31.03.2021, (3) Chairman Grievance Redressal Committee Sitapur, From 02.02.2021 to 31.03.2021, (4) Chairman Committee of Frequent Strikes and Boycott of Subordinate courts by the lawyers from 03.02.2021 to 31.03.2021, (5) Chairman Committee for Inspection of Shelter home of Sitapur from 03.02.2021 to 31.03.2021, (6) Chairman Novel Covid-19 Prevention of Corona Virus from 03.02.2021 to 31.03.2021, (7) Chairman Security Committee Sitapur From 03.02.2021 to 31.03.2021, (8) Chairman of Committee regarding of subordinate courts employees from class IV Cadre to Class III Cadre from 20.02.2020 to 31.03.2020, (9) Central Public Information Officer From 02.02.2021 to 31.03.2021, and (10) Chairman Human Rights Cases, from 02.02.2021 to 31.03.2021.

5. Respected District Judge himself has opined in Para 1(e)(iii) that the Officer has decided 19 old cases among the oldest cases of his court. The Officer has decided 10 cases which are more than 10 years old and 09 cases which are more than 05 years old.

6. It is also humbly mentioned that respected District Judge has opined in Para 1(g) that the Officer has achieved total 668.84 (126.37%) units against the targetted 529.23 units which is adequate.

In the above facts and circumstances, I want to mention here that the Hon'ble High Court has considered the Covid-19 Pandemic and relaxed in work done by each judicial officer and also directed that if the Judicial Officer has not done adequate work

during the Assessment Year it could not be treated adversely. I have always followed the orders and directed given by Hon'ble High Court in time in true letter and spirit.


