The learned District Judge also denoted about my health is sound and nothing adverse came to his knowledge about me.

To This end, I want to bring this fact into the kind notice of The hon'ble Court that Hon'ble The High Court letter no – C-671/CF(8) / 2021 dated July 17, 2021 regarding exemption / relaxation in the QUOTA/ UNITS for the judicial officers for the assessment year 2020-2021

keeping in the view the pandemic of Covid-19. The Hon'ble Court also mention in the above said letter that the sympathetic view be taken by the assessing authorities and they may ignore the shortfall treating the same as no adverse.

The learned District Judge assessed me in the the Annual Confidential Report for the assessment year 2020-2021 as only 'Good' in the point of overall assessment of the merit of the officer.


