Kindly refer to the subject captioned above.

In this regard, it is respectfully submitted that Respected the then District Judge, Allahabad (*who is presently posted as District Judge, Basti*) Mr. Vinod Kumar-III (I.D. No. U.P. 5401) has given the Annual Remarks for the year 2020-2021, in the which at the column of '*overall assessment of the merit of the Officer*', "**GOOD**" remark has been mentioned for the undersigned.

In this regard, I would like to humbly place the following facts for kind perusal :

1. That Respected the then District Judge, Allahabad has assessed "**GOOD**" to the undersigned at the column of '*overall assessment of the merit of the Officer*'.
2. That vide **Administrative Order No. 336 dated 09.11.2020** passed by Respected the then District Judge, Allahabad, undersigned was nominated as **Officer-in-Charge (Administration)** and **Officer-in-Charge, Matters relating to repayments**, as well as **Chairman of 9 Committees, Nodal Officer** for 1. signing Daily Sitting of Judicial Officers, 2. Magh Mela Camp. and 3. cluster training also. Besides this, vide the aforementioned Administrative Order, Respected the then District Judge had also nominated the undersigned as **member in 6 committees** constituted for various purposes. Being senior most Additional District Judge at Allahabad Judgeship, the undersigned has also worked as **Central Public**

7. That besides this, in compliance of the direction of Respected the then District Judge, the undersigned has also assisted him regarding examination for the post of Review Officer and Computer Assistant in the establishment of High Court, Allahabad.

8. That besides this, Respected the then District Judge, had often directed the undersigned for hearing and disposal of Civil Admissions and Bail Application on his behalf. For instance, copy of **Administrative Order Nos. 163/13.8.2020, 174/20.08.2020 and 313/22.10.2020** passed by Respected the then District Judge, Allahabad is being annexed herewith as **Annexure Nos. 8, 9 and 10.**

9. That despite of long closing of Court due to contagion of CORONA VIRUS (COVID-19 Pandemic) and aforementioned additional charges, the undersigned has disposed of following cases during the period from **01.04.2020 to 31.03.2021** :

1. **06 cases** which are more than **5 years old**
2. **02 cases** which are more than **10 years old**
3. **745** Bail Applications.
4. **01** Special Trials, which is also **more than 10 years old.**
5. **23** charges have been framed.
6. **5 cases** Civil Misc. Cases have been disposed of **on merits.**
7. Statements of **88 witnesses (207 pages)** have been recorded.
8. **09** Criminal Revisions and **02** Criminal Appeal have been decided on merits.
9. **15** Civil Revisions have been disposed of at the Admission stage.

The details of the aforesaid cases have been annexed in the Self Assessment Form, a copy of which is also being annexed herewith as **Annexure No. 11.**

10. That besides this. pursuant to the **Hon'ble High Court's Letter No. 3883/2020/Recruitment Cell/High Court, Allahabad dated 23.10.2020** regarding completion of **data entry in District Courts Establishment Portal**, I worked on **day-night basis** in compliance of order passed by the Respected the then District Judge's Order dated 24.10.2020 for completion of the data entry in D.C.E.P. within the stipulated period.



Copy of the **Hon'ble High Court's Letter No. 3883/2020/ Recruitment Cell/High Court, Allahabad dated 23.10.2020** and order dated 24.10.2020 passed by Respected the then District Judge on the said letter is being annexed herewith as **Annexure No. 12**.

11. That besides long closing of Court due to contagion of CORONA VIRUS (COVID-19) and huge administrative work, the undersigned has achieved total **1476.67 units** against the required **1200 units** during the period from 01.04.2020 to 31.03.2021.

12. That in the Annual Remark of the undersigned, Respected the then District Judge has mentioned that the **integrity** of the undersigned is **beyond doubt**, The **control of the undersigned over the office** is **effective** and **administrative capacity and tact of the undersigned** is also **good**, the **relations of the undersigned with member of the Bar** is **cordial**, **behavior of the undersigned to brother officers** is **cordial and helpful**, the **undersigned has made regular inspections of court and offices in its charge** and **such inspections** were **full and effective**, **undersigned is punctual and regular in sitting on dais**, **undersigned is amenable to the advice of the District Judge** and **superior officers**, the **behavior of the undersigned towards women** is **respectful** and **sensitive**. The undersigned is remarked as **fair and impartial in dealing with public and Bar** and **cool minded**. It has also been mentioned by the then District Judge that the **private character in public**, of the undersigned **does not adversely affect the official duty** of the undersigned and undersigned **avoided the unnecessary adjournments**.

But, in spite of mentioning above facts, respected District Judge has assessed the undersigned as "**GOOD**", which is inconsistent with the facts mentioned in the Self Assessment Form of the undersigned.

13. It is, respectfully, also submitted that the undersigned has worked hard in all committees to provide help to the Respected the then District judge for ensuring smooth administration. Besides, the closure of Court owing to COVID-19, even on Sundays, the undersigned has worked at the Camp Office of the Respected the then District, whenever desired by him. The undersigned always obeyed the orders of the District Judge and complied it in letter and spirits.

14. I always worked hard with Respected the then District Judge and working presently, which may be verified from Respected present District Judge, Allahabad.

It is, therefore, humbly requested that my representation may kindly be placed before Hon'ble Court for kind perusal and sympathetic consideration

regarding upgradation of the overall assessment of the undersigned, as given by Respected the then District Judge in the Annual Remark for the year 2020-2021.

This act of kindness of the Hon'ble Court will encourage the undersigned to achieve higher standards and will certainly boost the capacity of the undersigned.
