Representation for up-gradation of the Annual Remarks for the year 2020-2021.

Respected Sir,

It is, respectfully, submitted that Respected the then District Judge, Allahabad (who is presently posted as District Judge, Basti) Mr. Vinod Kumar-III (I.D. No. U.P. 5401) has given the Annual Remarks for the year 2020-2021, in the which at the columns of 'Quality Marshalling of fact, Appreciation of evidences and Application of Law' and 'overall assessment of the merit of the Officer', "AVERAGE" remark has been mentioned for the undersigned.

In this regard, I would like to humbly place the following facts for kind perusal :

- 1. That Respected the then District Judge, Allahabad has not assigned any reason for assessing "AVERAGE" the undersigned at the columns of 'Quality Marshalling of fact, Appreciation of evidences and Application of Law' and 'overall assessment of the merit of the Officer'.
- 2. That, during the financial year 2020-2021, the undersigned has worked as 1. Special Judge (E. C. Act) Allahabad from 01.04.2020 to 30.07.2020 and 2. Additional District & Sessions Judge Court, No. 3, Allahabad from 31.07.2020 to 31.03.2021.

The copy of details of sl. no. 9 of the Self Assessment Form Part I of the undersigned, showing above status, is being annexed as Annexure No. 1.

- That despite of long closing of Courts due to contagion of COVID-19 Pandemic and huge additional charges, the undersigned has disposed of following cases during the period from **01.04.2020** to **31.03.2021**:
  - i. 31 full contested cases.
  - ii. 04 cases which are more than 5 years old
  - 04 cases which are more than 10 years old

- iv. Total 579 Bail Applications
  - (1. 119 Bail Applications has been disposed of as Special Judge (E. C. Act) Allahabad and
  - 460 Bail Applications has been disposed of as Additional District & Sessions Judge Court No. 3, Allahabad.)
- v. Total **70 cases** has been disposed of during the period of 01.04.2020 to 31.03.2020.
- vi. All type of cases e.g. (1. Sessions Trial, 2. Special Trial, 3.Crl. Misc., 4. Crl. Revision, 5. Crl. Appeal, 6.Civil Revision, 7.Civil Appeal, 8.Misc. Civil Appeal, 9.Rent Control Appeal, 10.S.C.C. Suit, 11.S.C.C. Revision, 12.Guardian & Wards Cases, 13. bails etc. have been taken and disposed of by the undersigned during the period of 01.04.2020 to 31.03.2020, and the undersigned has paid special attention to the disposal of old cases.

The details of the aforesaid types of cases along with **year-wise break up** of it, have been annexed in the Self Assessment Form, a copy of which is also annexed herewith as **Annexure No. 2**.

That besides, long closing of Court due to contagion of CORONA VIRUS (COVID-19) and huge administrative works, during the period from 01.04.2020 to 31.03.2021, the undersigned has achieved total 1598.71 units against the required 1200 units, which 133.22 %.

6. It is, also relevant here that for the period from 1st April, 2019 to 31st March, 2020, the overall assessment of the undersigned in the Annual Remarks, as recorded by Hon'ble Administrative Judge/Reviewing and Accepting Authority Hon'ble Lordship Shashi Kant Gupta is as follows:

"The officer was fair and impartial in dealing with the public and Bar. His judgments were sound, well reasoned and expressed in good language and were based on Marshalling of facts and proper appreciation of evidence. Besides deciding the cases on criminal side, he has tried to dispose of the cases on civil side also. He has also tried to dispose of oldest cases. The Officer had made regular quarterly inspections of the courts. His relations with the member of the Bar as well as the brother Officer were cordial.

During my tenure it was observed that he is very submissive, sincere, intelligent and painstaking officer having a very good administrative capacity dealing with the matter tactfully taking keen and active interest in the matter entrusted to him. On an overall assessment, he is rated as an officer of outstanding merits having excellent career."

That in the Annual Remark of the undersigned, Respected the then District Judge has mentioned that the integrity of the undersigned is beyond doubt, The control of the undersigned over the office is effective and administrative capacity and tact of the undersigned is also good, the relations of the undersigned with member of the Bar is cordial, behavior of the undersigned to brother officers is cordial and helpful, the undersigned has made regular inspections of court and offices in its charge and such inspections were full and effective, undersigned is punctual and regular in sitting on dais, undersigned is amenable to the advice of the District Judge and superior

officers, the behavior of the undersigned towards women is respectful and sensitive. The undersigned is remarked as fair and impartial in dealing with public and Bar and cool minded. It has also been mentioned by the then District Judge that the private character in public, of the undersigned does not adversely affect the official duty of the undersigned and undersigned avoided the unnecessary adjournments.

But, in spite of mentioning above facts, respected District Judge has assessed the undersigned as "AVERAGE", at the columns of 'Quality Marshalling of fact, Appreciation of evidences and Application of Law' and 'overall assessment of the merit of the Officer', which is inconsistent with the facts mentioned in the Self Assessment Form of the undersigned.

- 8. It is, respectfully, also submitted that the undersigned has worked hard in judicial as well as administrative side. The undersigned always obeyed the orders of the District Judge and complied it in letter and spirits.
- **9.** It is, respectfully, also submitted that I always worked hard with Respected the then District Judge and working presently, which may be verified from Respected present District Judge, Allahabad.

It is, therefore, humbly requested that my representation may kindly be placed before Hon'ble Court for kind perusal and sympathetic consideration regarding upgradation of the remarks mentioned in the columns of 'Quality Marshalling of fact, Appreciation of evidences and Application of Law' and 'overall assessment of the merit of the Officer', of the undersigned, as given by Respected the then District Judge in the Annual Remark for the year 2020-2021.

This act of kindness of the Hon'ble Court will encourage the undersigned to achieve higher standards and will certainly boost the capacity of the undersigned.
