Subject:- Expunging of Remarks in the Annual Confidential Remark of 2020-21

Respected Sir,

With deep respect, I would like to submit that I came to know about the annual confidential remark of 2020-2021, dated 15-06-2021 through e-service portal of judicial officers though the respected district judge has given overall assessment as "good", but in the remark column i.e. column no. 4, it is being remarked that old cases have not been diffused. Execution "NIL" and Judgment quality is not up to the mark there is large scope of improvement in judgment writing.

In this regards my humble submission are as under –

1. Regarding progress and disposal of old cases as recorded in column no. 4 and execution cases as recorded in column no. 4, I have to submit that, I am a new entrant in the service and joined as ACJ/JM as on 15<sup>th</sup> November 2019. In this financial year, I was undergoing court training from 1<sup>st</sup> April 2020 to 14<sup>th</sup> September 2020. Again was undergoing online training of JTRI from December 7<sup>th</sup> 2020 to 31<sup>st</sup> Jan 2021. Thus I worked in the court in this financial year only for 90 days in this assessment year.
2. That due to wide spread of pandemic covid 19, Hon'ble High court Allahabad had given the orders not to record the statements and not to take coercive action against anyone. My first phase online training got over on 6<sup>th</sup> September of 2020 and still the above order of the Hon'ble High court Allahabad was still prevailing so I could not able to do more. Thereafter on 2<sup>nd</sup> of January the Honorable high court had given the permission to record the judgment. But at very point of time my 2<sup>nd</sup> phase online training was going on, which had lasted till 31<sup>st</sup> February of 2021. Nevertheless I tried my level best to dispose off the old cases and execution cases but I could have not done because of the short span of time.
3. That during this span of time only Nine execution cases remained pending in which cases bearing Ex 02/19 Mehndi Hasan Vs. Jakir Husain, Ex11/19 Deyendra Vs. Narsingh Pal, Ex 04/17 Sonpal Vs. Mohan lal, Ex5/17 Ram Naresh yadav Vs Rajendra singh, Ex 08/16 Ravindra Vs. Satish remained listed for steps to be taken by decree-holder. Case bearing no. Ex. 01/08 Satish Babu Vs Bhikam singh is remained pending for the disposal of application no. 60ga which is pertaining to objection related to Naksha Nazri and both the parties and their counsels were not coming. Case bearing no. Ex 01/14 Bhajan lal Vs. Savitri Devi is

remained pending for disposal of application no. 46ga . Case bearing no.02/08 Mahendra pal Vs Jaipal is remained pending for the hearing of application no. 122ga which is pertaining to objection paper no. 14c not being disposed of. Case bearing no. Ex 01/06 is remained pending for disposal of application no. 82ga which is related to the prayer of stoppage of Parwana.

4. That most of the execution cases being at primitive stage and in other execution cases both the parties and were not coming so the cases could not be disposed off within short period of 90 Working days , inspite of best effort made by me ,execution cases could not be ripened up due to above short span of time .
5. That during this sort span of time, I tried my best to dispose off old cases .Moreover I have able to disposed 15 of civil cases and 22 criminal cases during this assessment year.
6. That as so far as judgment are concerned, in my opinion , I have put my best efforts. Undoubtedly judgment writing is an art and there is always scope of improvement in judgment writing .And I will put more rigorous efforts to embrace the art of judgment writing.

Therefore it is respectfully prayed that Hon'ble court be pleased to consider my submission and expunge remarks recorded by the learned district judge in column no 4 of annual confidential report for 2020-21 .
