Subject: Representation aganist the adwers remarks
given in my Annual Confidential Report by Sri
Ravi Nath, The District judge, Deoria.


Sir,

It is most humbly submitted that with reference to above subject matter as adverse remarks given by The District Judge, Deoria with regard to colum numbers 01(b), 01(c), 01(d), 01(j), 01(m), 01(n) and Colum number 2, my submissions are as follows;

1. With regard to colum no. 01 (b), it relates to officer's fare and impartial dealing with the bar and public , respected Distrct Judge has remarked that I am not fair in dealing with public. But further he mentions "executive public officers" with whom I lost temper many times at the Monitorig cell meeting before the respected District Judge in his chamber.

It is most humbly submitted before Hon'ble Court that firstly, remark given by respected District Judge seems unrelated to qustion no. 01(b), remark does not relate to bar. As to public, remark is general and without any factual basis.

Secondly, I have been DDO of Deoria judgeship since my posting in Deoria ,April,2019 and Chairman Infrastructer had been 1st Addl. District Judge but on



23.11.2020 by order of respected District Judge I was ,in addition , made Chairman, Infrastructur and on 01.02.2021 another Add.District Judge was made Chairman, Infrastructure and I was removed from that responsibility, hence I participated in three monthly Monitoring cell meetings. Respected District Judge has not mentioned when ,at many times ,I lost temper and with which public executive officers. To my knowledge such thing never happened and he had never mentioned before me , verbally or by any written order, of my such alleged behaviour. First time he mentioned such fact of my frequently loosing temper in my Annual Confidential Report.


Moreover, in colum no. 01(i) , the respected District judge mentioned my relation with bar 'good'.

2. With regard to colum no 01(c), which relates to officer's behaviour in the Court , again the respected Distrcet Judge remarked against me with same fact as he mentioned above in colum 01(b) and it is humbly again submitted before Hon'ble Court that remark given by him is unrelated to qustion asked in colum 01(c). And there is no complain, oral or written, against me, either by bar or public.

3. With regard to colum no. 01(d), which relates to such private character of officer as to lower him in estimation of public and adversely affects the discharge of his duty, again the respected District Judge remarked against me on same vague facts mentined by him in colum no.01(b) and positivily held me of lower character without any advers fact or complain against me.

4. With regard to colum no. 01(j), the respected District Judge has stated that my behaviour with brother officers is not good. Firstly, he said that on many occaisions, I started shouting on and scolding the then CJM, Deoria Sri Bhupendra Pratap over baseless issues in his presnce. Secondly, he stated that on many occaisions I lost my cool over the new magistrates who have joined the service in the year 2019 and started shouting on, and scolding them over baseless issues.

Colum no.01(m) relates to whether officer is amenable to the advice of District Judge, on this point also repeating the same fact as in colum01(b),the respected District Judge remarked that I was not amenable to his advice as when I



was allegedly shouting and scolding to public executive officer or to then CJM Deoria , inspite of District Judge trying to stop, I did not stop.

Colum no.01(n) relates to officer's behaviour towards women but again repeating same allegations respected District judge observed that all lady officers who joined among judicial officers in 2019 in Deoria judgeship were on many occasions shouted on and scolded by me over baseless issues.

On all above remarks given by respected Distict judge , again I submit before Hon'ble Court that he had never told me of such thing personally nor he had given any written warning or D.O. to me.


So far, then C.J.M Sri Bhupendra pratap is concern. It can not be belived, even prima facie, that why should I shout on and scold him many times on baseless issues, especially always in the presence of the respected District Judge. No such instance is given in the A.C.R. If I can recall anything, once last year in rainy season substantial amount of water was logged in our colony, where then C.J.M was also residing on the first floor, as he was not coordinating with civil administration and not taking any interest for the drainage of the logged water from the campus, I had complained about this to The District Judge in presence of the C.J.M and it happened in very normal way. Beside that, no other instance I can recall.

All officers ,who joined service in 2019, each took 03 days training in my Court in very cordial atmosphere . I do not recall , if ever, I shouted on or scolded any officer ever. There is also no such complained against me by any officer, male or female.

I have always given sincere regard to respected Distict Judge and have always been amenable to his adivse. What he described in colum 01(m), I do not recall ,if happened ever.

It is also most humbly submitted that in my 20 years of service , this is first time , I have been given adverse remarks.

5. In colum no 2 , my over all assessment has been rated Average by the respected District Judge.



In this regard, it is most humbly submitted before Hon'ble Court that respected District Judge has in colum no 01(f) assessed my judgements based on facts and laws and reasoned.

in colum no 01(q) assessed my work Adequate (127.41% against required 100%)

in colum no 01(h) assessed my control over office and my administrative capacity and tact Good.

Hence, It is most humbly submitted that my representation be placed before Hon'ble Court for mercifull consideration and adverse remarks be expunged.
