Remark by learned District & Session Judge , Muzaffarnagar-

“3 of inspection court & offices which were effective . **No inspection was made while posted as Secretary DLSA**

With due respect regarding remark in column 1(k) , it is most humbly submitted that I have made regular inspections of DLSA office while I was posted as Secretary DLSA and the inspections were made on 16/03/2020 and 20/06/2020 but due to typographical error and mistake it was not mentioned in the inspection column made as Annexure submitted with Self Assessment . Copy of both the inspections are attached for kind consideration for Hon'ble Lordship as Annexure no. 1 and 2 .

It is most submitted that the applicant has organised legal literacy camp as per NLSA calendar of the year and made regular inspections of District Jail and Shelter Homes as per direction given by SLSA /NLSA as secretary of DLSA and sent all compliance report to concerned office through (Chairman DLSA Respected District & Session Judge , Muzaffarnagar on time.

It is most humbly submitted that the applicant has joined the present court of ACJM , Court No 2 on 24/07/2021 and since then the applicant has efficiently achieved the target units and applicant's percentage of work is 174.5% which is above the desired target.
