Subject- Representation regarding remarks recorded by the District Judge in my ACR (2020-2021).

Respected sir,

This is most respectfully submit that I received my Annual Confidential Remarks through online portal eServicesJO on July, 20, 2021. After perusal of the ACR it came to my knowledge that the comments in column no. 1(e)(iii), 01 (e)(iv), 01(g) and 01 (g)(iii), recorded by the District Judge is as under-

01(e)(iii)	Disposal of old cases (Give number and year of old cases decided)	Officer has decided- O.S. - 1/03,2/11, 1/20 Execution - 1/12
01(e)(iv)	Progress and Disposal of execution cases	Nil
01(g)	Whether disposal of work is adequate (Give percentage and reasons for short disposal if any)	Against 619.44 target units officer has achieved 335.25 units which is inadequate.
01(g)(iii)	Number of civil cases decided on compromise/alternate dispute resolution.	3 cases

In this regard it is submitted that the facts of the matter according to my self assessment 2020-2021 submitted by me are that-

1. Disposal of old cases and their numbers are – OS. 124/03, 159/11, 271/11.  
Execution – 03/12.  
[Column no. 01(e)(iii)]
2. The undersignee has decided 01 Execution case with full satisfaction of the parties. (Execution case no. 03 of 2012, Rambaran vs. Raghunath) [Column no. 01(e)(iv)]
3. The undersignee has achieved 441.75 Units against targeted units 619.44, which appears that due to typological error the number 335.25 is wrongly typed in place of 441.75 units. [Column no.01 (g)]
4. The undersignee has decided 09 cases of civil nature through compromise/alternate dispute resolution, which appears that due to typological error the number 03 is wrongly typed in place of 09. [Column no. 01(g)(iii)].


It is also submitted that the I have only civil work in the outlying Chunar, Mirzapur. I made all possible efforts to decide and dispose maximum number of cases. But unfortunately couldn't achieved the prescribed target because of non appearance of parties, non co-operation of counsels and non running of normal functioning of the court due to pandemic of Covid-19. During the normal functioning of the court between January 2021- March 2021, I achieved 314.26 units against the target of 206.64 units, 04 contested judgments, 01 execution, 05 compromises, 04 ex parte judgments and other judicial work. With reference to letter no. C-671/ CF(B) / 2021 : Dated : Allahabad July 17, 2021, related exemption/relaxation in the Quota/Units prescribed for the judicial officers for assessing year of 2020-2021 keeping in view pandemic of Covid-19 , I also humbly request to the Hon'ble court to have mercy while considering the overall remark of the applicant.

It is requested to kindly place my representation along with my ACR before Hon'ble court for necessary orders.
