**Subject: Representation against adverse remarks recorded for the year 2020-2021 by the then District Judge, Etah, on some scores and against overall assessment as "Average Officer".**

Respected Sir,

On the above mentioned subject respectfully I beg to submit my explanation on following grounds:

That I have joined judicial service on 23<sup>rd</sup> January 2017 and during the period of 18.07.2017 to 25.01.2019 I had been posted as Judicial Magistrate, Etah. From 26.01.2019 to 12.04.2021 I was transferred in the court of Civil Judge (Jr. Div)/J.M. Jalesar, Etah. On the basis of my Self Assessment Form for the year 2020-2021 (Period 01.04.2020 to 31.03.2021) Learned District Judge, Etah recorded following remarks against following columns of "Annual Confidential Remarks-Sheet"

**A. [01 (f) Whether Judgements on facts and on law are on the whole sound, well reasoned and expressed in good language?**

**Judgements are not sound on whole.]**

- With all due respect it is urged that vide **Office Memorandum No. 176/Admin (Services)/2021 dated: April, 08, 2021 of High Court of Judicature at Allahabad**, I have been promoted from Junior Division Cadre to Senior Division Cadre.
- For the purpose of promotion Hon'ble High Court Allahabad called for 3 judgements delivered by me for consideration, on the basis of which I have been promoted.
- No observation or remark in this regard has ever been made by Hon'ble High Court Allahabad or any Appellate Court in

the entire term of my service till now and hence I have been promoted.

**B. [01 (L) His punctuality and regularity in sitting on the dais in court during court hours?**

**Not punctual in sitting on dais]**

- With all due respect it is urged that no such complaint has ever been recorded by my previous Learned District Judges nor by any Learned Advocate.
- I have always discharged my duties with utmost punctuality and in strict adherence to covid-19 guidelines issued by Hon'ble High Court of Allahabad time to time

**C. [Column 4 other Remarks, if any:**

**Para1: "Many times on surprise inspections she was not found on dais during court hours but she has shown herself on dais at the relevant time. On asking the reason no satisfactory reply given, for that Do letter was served on her"**

- With all due respect it is again urged that no D.O letter has been served upon me regarding punctuality in the Self Assessment Year 2020-2021.
- No complaint regarding punctuality has neither been recorded by my previous Learned District Judges nor by any Learned Advocate.
- Despite of Covid-19 guidelines in force issued by Hon'ble Allahabad High Court, I have never left the court premises before 05.00 P.M in the tenure of the then Learned District Judge, Etah.
- I request you to kindly take notice of **Column 01(m) "whether amenable to the advice of District Judge and other Superios Officers-Yes"** which is self explanatory of my conduct as a judicial officer.

**Para 2: "She has very poor knowledge of criminal law. In crime No. 117/19, State Vs. Sonu under section 363, 366, 368, Police Station Avagarh, District Etah, she has discharged accused Sonu after taking cognizance on his chargesheet though she has no jurisdiction to discharge the accused in case triable by Session."**

- Very humbly it is stated that the copy of the relevant order is attached for kind perusal of the Hon'ble Court.
- There is no mention of **"discharge"** in the order which was passed on the application moved by the State/Prosecution.
- The adverse remarks made by the Learned District Judge appear to be misconceived and may kindly be expunged.

I respectfully beg to state that in view of above stated circumstances and my explanations the remarks may kindly be

It is further very humbly requested that the Hon'ble Court may kindly consider my case for **upgradation** of overall assessment recorded as **"Average Officer"** by Learned District Judge, Etah in **Column No. 2**. I shall be highly obliged.
