Respected Sir,

Kindly refer to the subject mentioned above. In this regard, it is respectfully submitted that the then District Judge, Allahabad (who is presently posted as District Judge, Basti) Mr. Vinod Kumar-III (I.D. No. U.P. 5401) has given the Annual Remarks for the year 2020-2021, in the which at the column of 'overall assessment of the merit of the Officer', "**Good**" remark has been mentioned for the undersigned.

In this regard, I would like to humbly place the following facts for kind perusal :

1. That Respected the then District Judge, Allahabad has not assigned any reason for giving the remark "**Good**" to the undersigned at the column of '*overall assessment of the merit of the Officer*'.

2. That vide **Administrative Order No. 336 dated 09.11.2020** passed by Respected the then District Judge, Allahabad, undersigned was nominated as Chairman in 1 committee and member of 6 committees. The details of the said charges has been mentioned by the undersigned are as follows :

as Chairman

1. District Court Security Committee.

as Member

1. Grievance Redressal Committee of Advocates and Class III employees of District Court Allahabad.

2. COVID 19 Pandemic Prevention Committee.

3. Protocol Summon Cell, Security of Entire Court Premises and Residences of Judicial Officers.

The Copy of the **Administrative Order No. 336 dated 09.11.2020** passed by Respected the then District Judge, Allahabad is annexed herewith as **Annexure No. 1.**

3. That despite long closing of Court due to contagion of CORONA VIRUS (COVID-19), during the period from **01.04.2020 to 31.03.2021**, the undersigned has decided :

1. **27 cases** which are more than **5 years old**
2. **21 cases** which are more than **10 years old**
3. **09** Contested Judgments after full trial.

The details of the aforesaid cases have been annexed in the Self Assessment Form PART II-A, PART II-B and PART -I

4. That despite long closing of Court due to contagion of CORONA VIRUS (COVID-19), during the period from 01.04.2020 to 31.03.2021, the undersigned has achieved total **1700.47 units** against the required **1200 units**, which is approximately **141 per cent**.

5. That in the Annual Remark of the undersigned, Respected the then District Judge has mentioned that the **integrity** of the undersigned is **beyond doubt**, undersigned is **fair and impartial in dealing with public and Bar** and **cool minded**. It has also been mentioned by the District Judge that the **private character in public**, of the undersigned **does not adversely affect the official duty** of the undersigned and **control of the undersigned over the files and office is proper** and undersigned **avoided the unnecessary adjournments**. In spite of mentioning above facts, respected District Judge has assessed the undersigned as "**Good**", which is inconsistent with the facts mentioned in the Self Assessment Form of the undersigned.

6. It is also pertinent here that for the period from 1st April, 2019 to 31st March, 2020, the overall assessment of the undersigned in the Annual Remarks, as recorded by Hon'ble Administrative Judge/Reviewing and Accepting Authority Hon'ble Lordship Shashi Kant Gupta is as follows :

"The officer was fair and impartial in dealing with the public and Bar. His judgments were sound, well reasoned and expressed in good language and were based on marshalling of facts and proper appreciation of evidence. Besides deciding the cases on criminal side he has tried to dispose off the cases on civil side also he has also tried to dispose off oldest cases. The officer had made regular


quarterly inspection of the course. His relations with members of the bar as well as brother officers were cordial. During my tenure it was observed he is a very submissive sincere, intelligent and pain staking officer having a very good administrative capacity dealing with the matters tactfully taking keen and active interest in the matters interested to him .
