Subject- Representation against remarks given by the respected district judge in annual confidential remarks for the assessment year 2020-2021

Sir,

It is humbly submitted that remarks dated 16.08.2021, given by the respected district judge in annual confidential remarks for the assessment year 2020-2021 were communicated to me through online e-portal.

With all due respect, I humbly represent against the remarks given by the respected district judge in **column no. 01(e)(iv) regarding progress and disposal of execution cases** wherein "nil" remark given and **column no. 01 (g) regarding whether disposal of work is adequate (Give percentage and reasons for short disposal, if any)** wherein "Disposal of work is adequate. Total 1344.46 units are achieved against the target of 1200 units" remark given by respected district judge.

In this respect I humbly wish to submit as under-

I humbly beg to submit that in aggregate I am awarded "Good" entry but my humble submission is that the respected then diistrict judge in his remarks in **column no.01 (e) (iv)** regarding progress and disposal of execution cases, "nil" disposal has been recorded. Here it is noteworthy that through the attached proforma under column no. 7 of the same self assessment form a detail year wise disposal report in pdf formet has been furnished wherein at page no.11/12 regarding year wise break up of execution cases, 01 execution case have been shown as decided (contested disposal) out of 04 pending cases. Thus respected district judge has given a wrong remark of nil disposal of execution cases despite of available figure of 01 contested disposal of execution case out of total pendency of 04 cases.
(the relevent figures/data are attached in yearly self assessment)

Regarding remarks in **column no.01 (g)** wherein "Disposal of work is adequate. Total 1344.46 units are achieved against the target of 1200 units" remark has been given by the respected district judge. Needless to reiterate that through the attached pdf proforma in column no. 15 (details of the work by the officer) total 1363.86 units achieved by the officer has been shown and further in column no. 2 of self assessment form part II the same figure has been mentioned. Thus despite of clear and details figure of disposal of work i.e. 1363.46



units achieved by the applicant, only 1344.46 units has been shown by the respected district judge which has been wrongly mentioned.
(the relevent figures/data are attached in yearly self assessment)

Needless to mention that During the assessment year, from the month of april to december, the court proceeding was withheld in complience of direction in light of corona pendamic threst. Thus only after the month of december (total 2/3 months) the court could start proper functioning. Respected district judge could not take all these fact in to account while recording the annual remarks of the applicant.

Therefore i most humbly submit that "nil" disposal of execution cases entry and "total 1344.46 units are achieved" entry are neither true nor properly justify the efforts which i put in disposal of execution and many other cases during the assessment year. Therefore it is most humbly prayed to the hon'ble court that the above mentioned facts may kindly be considered and the "nil" entry in **column no. 01 (e) (iv)** regarding disposal of execution cases and "Total 1344.46 units are achieved against the target of 1200 units" entry in **column no. 01(g)** regarding whether disposal of work is adequate (Give percentage and reasons for short disposal, if any), may kindly be considered and entry be upgraded, expunging the critical remarks recorded by respected district judge, to any other higher suitable entry which the hon'ble court deems fit.


It is requested that my submission may kindly be placed before the hon'ble court for kind and sympathetic consideration.
