**Subject: "Regarding the Representation against remarks of respected district judge in ACR 2020-21."**

Sir,

I most humbly beg to state that the Annual Confidential Remark (ACR) 2020-21 of the then respected District Judge Pratapgarh, has been received by me on e-service portal, in which the over all assessment of the merit of the officer is mentioned as "Good".

I most humbly want to submit my Representation on the following 3 points of the above ACR.

Following are the three points mentioned in ACR 2020-21 :-

**First Point**

**01 (e)(iii).**

Disposal of old cases(Give number and year of old cases decided): As per information furnished by the officer, he has disposed 188 cases (more than 05 year old) and 126 cases (more than 10 year old). He has not provided any detail of disposal of old cases in the yearwise breakup. It requires verification. The officer has attached only 01 contended Judgement, 01 Ex- parte and 01 compromise Judgement. Had he disposed many old cases, than he would have attached those Judgements instead of Ex-parte-compromise Judgements.

**My submission on first point 01 (e) (iii);** I most humbly state that I have not submitted details of disposal of old cases in yearwise breakup, Therefore I am submitting the required information regarding disposal of old cases in yearwise breakup in the attachment.

I have decided only 01 contended Judgement, 01 Ex- parte and 01 compromise Judgement due to less working days, because i was on field training from 01.04.2020 to 16.10.2020 and from 23.10.2020 to 05.11.2020 thereafter participated in the online induction training programme (IIIrd phase) organised by JTRI, Lucknow from 07.12.2020 to 30.01.2021. Old cases, which were disposed by me, were non-contested and dismissed for default hence those cases were not attached by me in ACR 2020-21.

### **Second Point**

**01 (e)(iv).** Progress and disposal of execution cases: 16 Execution cases disposed but he has not provided any detail of disposal of these cases in the yearwise breakup. It requires verification.

**My submission on second point 01 (e)(iv);** I most humbly state that I have not submitted details of disposal of execution cases in yearwise breakup, Therefore I am submitting the required information regarding disposal of execution cases in yearwise breakup in the attachement.

### **Third Point**

**4. Others remarks, if any;** He has not provided any detail of disposal of old cases in the yearwise breakup. It requires verification. The officer has attached only 01 Contested Judgment, 01 Ex-parte and 01 Compromise Judgment. Had he disposed many old cases, than he would have attached those judgment instead of Ex-parte – Compromise judgments.

**My submission on second point 4;** I most humbly state that I have not submitted details of disposal of old cases in yearwise breakup, Therefore I am submitting the required information regarding disposal of old cases in yearwise breakup in the attachement.

I have decided only 01 conteneded Judgement, 01 Ex- parte and 01 compromise Judgement due to less working days, because i was on field training from 01.04.2020 to 16.10.2020 and from 23.10.2020 to 05.11.2020 thereafter participated in the online induction training programme (IIIrd phase) organised by JTRI, Lucknow from 07.12.2020 to 30.01.2021.
