Subject:-Submission of Representation against the remark given by the Ld. District Judge, Pratapgarh (presently Ld. District Judge, Kanpur Dehat) at point No. 01(e) (iv)- progress and disposal of execution cases and prayer for upgradation of ACR entry.

Respected Sir,

I most respectfully beg to submit my representation on the subject noted above as under:-

In this regard I respectfully submit that from April 2020 to January 2021, total 23 execution cases were pending in my court Addl. Civil Judge (Jr. Div.), Court No. 19, Pratapgarh. The only adverse remark rewarded by the Ld. District Judge in column no. 01(e) (iv) is quoted here thus: only 01 execution case is disposed (otherwise). No interest shown in disposal of execution cases on full satisfaction basis. Although the yearwise breakup shows pendency of 23 execution cases. In this regard I humbly submit that the assessment year, 2020-21 was not normal year due to COVID-19 pandemic in that year the whole country was suffering from COVID-19 pandemic which has its effect today also. On 25-03-2020 nation wide lockdown was imposed, due to which the court's functioning was also hampered. After considering national lockdown and spread of Corona virus, the Hon'ble Chief Justice of Allahabad High Court in PIL No. 564/2020 passed remedial order dated 26-03-2020 with certain direction, one of which was "(iii) If any Orders of eviction, dispossession or demolition are already passed by the High Court, District or Civil Court, the same shall remain in abeyance for a period of one month from today;". This direction regarding eviction, dispossession or demolition continued till July 2020. But the Hon'ble High Court passed direction for functioning of the Court from time to time which directed courts to mostly deal with urgent matters. The normal functioning of court came into force after 05-01-2021 as all prior directions regarding functioning of the courts were revoked. In the assessment year 2020-21 my total working days were 163 becaused due to lockdown and court being in containment zone court was closed for number of days. It is humbly submitted that I tried my best to dispose execution cases pending in my Court. Even after 05-01-2021 the parties of the cases were not attending court's proceeding due to COVID-19 Pandemic.

It is humbly Submitted that in the assessment year 2020-21. I disposed 148 cases (more than 05 Years old) and 104 cases (more than 10 years old). Two Civil actual full Contested Case i.e. O.S No. 310016/1982 and 1628/1999 and One Domestic Violence actual contested case were disposed. Total 1252.30 units were achieved against target units of 534.64 i.e. 234.32 % units.

I dutifully assure the Hon'ble Court that I will try my best to dispose maximum number of execution Cases.

In view of the grounds enumerated above and the disposal donc by me, I with utmost respect submit before your goodself that kindly place my application before the Hon'ble Administrative Judge for the District of pratapgarh for the year 2020-21 to expunge the remarks of Ld. District Judge with regard to disposal of execution cases and to upgrade my over all assessment. I shall be highly obliged.
