Subject:- Regarding upgradation of annual confidential remark for the assessment year 2020-2021 and request for expunging certain critical remarks recorded by Respected Mr. Sanjay Shankar Pandey, District Judge Gonda in my self-assessment column number 01(k) and other remarks in column number 4,

Respected Sir,

The applicant most humbly begs to submit his representation on the above subject matter as under:

- In pursuance of the ACR recorded by the Respected District Judge Gonda which has been communicated to me through e-Services for Judicial officers Portal dated 07-10-2021.
- That the Civil court at Gonda remained closed due to Covid-19 Lockdown from 01.04.2020 to 31.05.2020.
- During the period of assessment year 2020-2021 Learned District Judge, Gonda, While recording my annual confidential remark observed as:-**Overall assessment of the merit report of the officer is GOOD.**
- That against point no. 01(k) of my A.C.R. which states, "Whether the officer has made regular inspections of his Court and offices in his charge and whether such were full and effective", The learned District Judge has observed that "The officer has made quarterly inspections regularly, Court and office in his charge but the inspection is not effective." And In column no 4 "Though overall officer has good administrative capability but he never comes forward to share their responsibility. Officer has not used his ability to supervise in his own office in accordance with rule and circular letter of the Hon'ble Court. There are chance of improvement in his administrative capacity"
- That during the assessment year 2020-2021, I was posted as Additional District and Sessions Judge/Special Judge (E.C.Act)/Gangster Act (Court started from 17-02-2021 to 31-03-2021) Additional District and Sessions Judge Court No.-05, Additional District and Sessions Judge/FTC-II/Special Judge Gangster Act (Dated 14-10-2020 to 09-02-2021) Gonda. Apart from this the then Respected District and Sessions Judge, Gonda nominated me as the incharge of Enquiry section of Gonda Judgeship on dated 29-07-2020. **Being a Presiding Officer of the**



Additional District and Sessions Judge/Special Judge (E.C.Act)/Gangster Act, Additional District and Sessions Judge Court No.-05, Additional District and Sessions Judge/FTC-II/Special Judge Gangster Act Gonda. I have conducted four quarterly inspections of the Court/office and being incharge of Enquiry Section three quarterly inspection of Enquiry section of Gonda Judgeship during the assessment year 2020-2021 as per General Rule (Civil) General Rule (Criminal) and Circular letters of the Hon'ble Court. (Annexure Nos. 08 attached for ready reference)

- That the applicant never received any direction either orally or in writing by the Respected District Judge Shri Sanjay Shanker Pandey during the above assessment period about the administrative capacity in the court and office. Besides, in **Column No. (1) (h) of the ACR** the Respected District Judge Shri Sanjay Shanker Pandey has observed that **"Control over the office and administrative capacity and tact is proper and effective"**. In the annual inspection conducted by the Respected District Judge Shri Sanjay Shanker Pandey on dated 15-02-2021 remarked **11(d)** that **"The Presiding officer fixed sufficient cases on each and every working day and performed his judicial duties and followed the pandemic Covid-19 guidelines issued by the Hon'ble high Court."** Hence the entry awarded by the Respected District Judge Shri Sanjay Shanker Pandey in column no (1) (k) and (4) may kindly be expunged.

- That the applicant never received any direction either orally or in writing about sharing of any type of responsibility.

- That the applicant never received any direction from the then Respected District Judge about work efficiency, inspection of office and the Court or about the rules, regulations and circular letters of the Hon'ble court. During his tenure the applicant has never received any D.O. letter or any other direction about non-compliance of such rules, regulations and circular letters of the Hon'ble Court.

- That the applicant has made all possible efforts for proper functioning and working of the Court even during the pandemic of Covid-19 period.

- That the applicant has done his work with full potential and conscientious and has always made keen interest to the best capability for the proper functioning and running of Court according to the rules and regulations/circular letter of the Hon'ble Court in the pandemic period and **disposed 165 cases after actual full contested and one execution case and as per the directions issued by the Hon'ble Court, required unit target is 681.76, but I have achieved 1339.58 units in the pandemic period. Which is 196.48% above the beyond established norms.**


- That the applicant hence forth with always make efforts and is intently determined to improve his administrative work to his full capabilities.
