Subject: Representation against the Annual Confidential Remark awarded by the Hon'ble Administrative Judge, Barabanki for the year 2020-21.

Respected Sir,

I have honor to submit that most of the period of about one year of my judicial service was badly affected due to Covid-19. The court was either closed or judicial work paralised due to pandemic of Covid-19. I am Direct Recruit from HJS 2018 (third) batch and taken over charge for the first time to the Barabanki Judgeship on dated 19.03.2020. About half of my Service period was spent in the court and field training. In spite of Covid-19 pandemic and the time spent in court and field training, I have done my best to achieve the target unit of work.

The Hon'ble High Court vide letter number- **C-671/CF(B)/2021: Allahabad: July 17, 2021** has been pleased to pass order for exemption / relaxation as follows —

“ The exemption/relaxation in the quota/units prescribed for the judicial officers for the Assessment Year 2020-21, keeping in view the pandemic of Covid-19. In case officers find shortfall in their out-turn because of irregular working of the courts during the pandemic period in the Assessment Year 2020-21, the sympathetic view be taken by the Assessing Authorities and they may ignore the shortfall treating the same as no adverse.”

The respected District Judge has assessed my work, conduct and behavior as 'very good officer.' My work, conduct and behavior has also been appreciated by the members of bar and all concerned to the judicial fraternity.

In the remarks column -4 of my self Assessment, the respected District Judge has observed as follows —

“Smt Nazneen Bano is the first appointee from Direct recruit of HJS. She is an obedient and diligent judicial officer. In spite of due diligence, she could not achieve the target due to short span after her training. Her explanation vide letter dated 24.06.2021 as well as mentioned in the proforma is self explanatory. Keeping in view the diligence of the officer concerned and also relaxation provided by the Hon’ble Court’s vide letter number - C 671/CF (B)/ 2021: Allahabad : July 17, 2021, she is rated a “very good” officer.”

In spite of newly direct recruited from HJS 2018 (third) batch and facing the pandemic of Covid-19, I have decided 06 Sessions Trials, 02 Criminal Appeals, 02 Criminal Revisions and several bail applications etc. I have discharged the Judicial and Administrative work assigned by the respected District Judge from time to time. I have done my best to achieve the required target of unit work and achieved 343.35 units out of the target 402.96 units. My achievement of work unit was nearby the targeted unit in spite of the unfavorable and unpleasant situation of Covid-19.

Due diligence, hard work, devotion towards the fraternity and bright career of myself be evaluated with kindness. My work, conduct and behavior is appreciated amongst all concerned. Merciful and kindness of the Hon’ble Court is needed to restore the overall assessment of “very good” recorded by the respected District Judge. Needless to submit that awarding an appreciable remark to the judicial officer encourages to hard work and devotion towards fraternity. The representation is hereby made with prayer to the Hon’ble Court for kind and merciful consideration to restore the overall Assessment recorded by the respected District Judge.

It is therefore requested to your good-self to place my humble representation before the Hon’ble Court, so that the Hon’ble Court may kindly and graciously be pleased to upgrade the overall Assessment for the year 2020-21. I will be much obliged.
