**Subject: Representation with regard to upgradation of Annual Remark "good", awarded by the Hon'ble Court to me for the Assessment year 2020-21.**

Sir,

With regard to the above subject, It is my humble submission that I performed judicial and administrative work from 01.04.2020 to 31.03.2021, on the post of Presiding Officer Motor Accident Claims Tribunal, Barabanki. I had submitted my self-assessment for the year 2020-21 to the Hon'ble High Court whereupon, Hon'ble the Administrative Judge had been pleased to award me overall assessment "good". The above Annual Remark is uploaded on my e-services portal which, I noticed on 06.12.2021. (Annexure no.01)

I am submitting my representation for upgradation of the above overall Assessment "good" for the year 2020-21, on following grounds:

i)-During the Assessment year, 2020-21 the Court/Tribunal remained closed from 01 April,2020 to 08 June,2020, under the direction of the Hon'ble High Court due to spread of Covid-19 Pandemic and thereafter, the Court/Tribunal opened but with certain Corona Protocols including social distancing and appearance of the parties only in urgent matters. Initially, the parties were reluctant to appear before the Tribunal due to fear of Corona Pandemic which resulted in slow progress in disposal of cases. Thereafter, as the Court work started to speed up then vide letter no.285(1)/Admin.(Services)/2000, dated Allahabad, July30,2020 (Annexure no.02) of the Hon'ble High Court, I was attached with the three Members Hon'ble Enquiry Commission, headed by Dr. Justice B.S. Chauhan(former Judge Supreme Court of India), constituted



by the Government of U.P. under the direction of Hon'ble Supreme Court, passed in W.P.(S)-177/2021, titled Ghanshayam Updhayay Vs. State of U.P. and others. The above Hon'ble Enquiry Commission was constituted with regard to Bikru massacre by Vikas Dubey and his associates and the death of Vikas Dubey and others in police action.

ii)- I remained attached with this Hon'ble Enquiry Commission from 01 August,2020 to 31 March,2021, wherein, I performed my work with utmost sincerity and devotion. Under the direction of the Hon'ble Enquiry Commission, I performed judicial work in Motor Accident Claims Tribunal, Barabanki on different dates and in March,2021.

iii)- Due to my attachment with the Hon'ble Enquiry Commission for about 08 months and due to closure of Court/Tribunal for more than 02 months due to Corona Pandemic, whatever little time, I got to perform judicial work as Presiding Officer, Motor Accident Claims Tribunal, Barabanki my output of work percentage was 181.86% for the year 2020-21, which was in excess of required work done of 100% ( 399.30 units against required 219.7units).

iv)- I took special care in deciding old and very old cases and, in all, I decided 14 old cases of more than 05 years and 10 years old. I also disposed of 36 cases in Lok-Adalat.

v)- My overall Assessment of the previous five years awarded by the Hon'ble High Court(Annexure 03), is as follows:

- a)- Assessment year 2015-16= V.Good
- b)-Assessment year 2016-17= V.Good
- c)- Assessment year 2017-18= Outstanding
- d)- Assessment year 2018-19= Outstanding
- e)- Assessment year 2019-20= Outstanding

vi)- During the entire year, no complaint was made against me by any litigant or member of the Bar with regard to my work and conduct in the Court.

vii)- During the above entire period 2020-21, no comment/explanation was sought from me by the Hon'ble High Court with regard to any subject.



viii)- Hon'ble the Administrative Judge, while awarding overall Assessment "good" has not made any comment with regard to my work and conduct of the aforesaid period.

I, therefore, request you to kindly place my representation before the Hon'ble Court for the upgradation of overall Assessment "good" awarded to me for the year 2020-21, for further necessary action, and, if any delay is found in moving this representation, the same kindly be condoned.
