Subject Representation regarding Annual Confidential Remarks for the year 2021-2022 recorded by the then Principal Judge, Family Court, Budaun.

Respected Sir,

Most respectfully I would like to submit that the applicant is posted at district Budaun as Additional Principal Judge, Family Court. It is most humbly submitted that I had done my duty with full diligent, honesty and hard work. The then Principal Judge, Family Court, Budaun has stated that I have good, cordial relationship with Bar, Officer's and other members of the institution and my judgements are well reasoned and sound.

In the Self Assessment Year 2021-2022 out of the total targeted unit 517.76 I have achieved 1337.55 units which is almost more than 2.5 times of the required unit.

It is for your kind notice that the applicant had disposed of maximum old cases and execution cases but then Principal Judge, Family Court, Budaun while recording remarks for the year 2021-2022 has in column 01 (e)(iii) Old cases and in column 01 (e)(iv) Disposal of execution cases has inadvertently wrongly mentioned the figures. The then Principal Judge, Family Court, Budaun has mentioned in :-

was a new institution and so notice was sent to Judgement Debtor.)

In this way **the applicant has in the self assessment year 2021-2022 has disposed of total 183 execution cases (Both Civil and Criminal)** while the then Principal Judge, Family Court, Budaun has mentioned only 03 cases disposed of by the applicant. ( Annexure attached).

Most respectfully I would like to submit that inspite of adverse circumstances of pandemic Covid-19 I had worked above my ability for the institution and disposed of maximum old cases and execution cases but they have not been mentioned by the then Principal Judge, Family Court, Budaun and I have been assessed as a "very good officer." This overall assessment has demotivated me.

The actual figure of disposal of old cases as well as execution cases are much more than the figure mentioned by the then Principal Judge, Family Court, Budaun. Had he been in the knowledge of, actual number of disposal of these cases he might have awarded me as an **"Out standing Officer"**

It is therefore, requested that my representation be placed before the Honourable Court for kind consideration.

I shall be highly obliged for this act of kindness.
