Sub : Representation to then Hon'ble Administrative Judge of the District Court Gorakhpur against the A.C.R. recorded by the District Judge Gorakhpur against the applicant for the Assessment Year 2021-2022

Respected Sir,

I most respectfully submit my representation to the subject noted above against the A.C.R recorded by the respected District Judge Gorakhpur, in the assesment year 2021-2022. In that period, I was posted at Gorakhpur as Additional District and Sessions Judge Gorakhpur.

Respected District Judge Gorakhpur in his assessment rated me as a "Good Officer." In the assessment year, my outturn was 1757.59 units against the required 1200 units, despite the frequent closure of court due to pandemic Covid-19. I further humbly submit that in the said assesment period, I was firstly transferred from Kanpur Nagar to Santkabir Nagar and after a few months, I was again transferred from SantKabir Nagar to Gorakhpur. As result of the said transfers, the rhythm of my work and disposal suffered. Since I was posted in the Courts which were earlier vacant, it took a considerable amount of time to ensure smooth functioning of my court. My court have jurisdiction of cases related to P.C. Act of 18 districts. When I joined that court no pairwikar were appointed from those districts, most of the files were at very early stage. Many correspondance were made by me to officials of those districts resulting in the appointment of pairwikar from most of the district so that compliance of process issued made easy. Since my posting in this court 1237 pages evidence were recorded during the assessment period. During the assessment period, I disposed off as many as 55 cases which were more than five years old and 32 cases which were more than 10 years old, 2 execution cases were decided out of total pendency, 1237 pages evidence were recorded. Disposal of files of P.C. Act and evidence recorded were comparatively higher than other Presiding Officers posted in this court earlier. I also Disposed off three Departmental Enquiry. During the entire assessment period no complaint made against me by anyone, as far as I know. I was rated as a "Very Good" officer in the previous two assessment years i.e. 2020-2021 & 2019-2020 and in the year 2018-2019 rated as a "Outstanding" officer by the Hon'ble assessing authority.

In view of the above , my A.C.R. deserves to be upgraded.

I therefore, very humbly request you to kindly place my representation before the then Hon'ble Administrative Judge, Gorakhpur for the kind consideration of his lordship for upgrading the good remarks of the Respected District Judge Gorakhpur recorded in the A.C.R. for the assessment year 2021-2022.
